Whereas, the Administrative Department vide letter No. Edu-I/615/2018, dated 20/08/2018, read with No. Edu-I/522/2018, dated 06/09/2018 together with other districts forwarded the selection list of 30 Junior Assistants of District Kupwara (OM=16, RBA=09, SC=04, ST=01) issued by the J&K Service Selection Board Srinagar, vide letter No. SSB/Secy/Sel/2018/7737-43 dated 06/07/2018.

Whereas, the appointment order of selectees (except those in whose favour recommendation was kept withheld by J&K Service Selection Board for want of certain clarification) was issued vide order No. 1162-DSEK of 2018 dated 10/09/2018;

Whereas, 05 (five) appointees in District cadre Kupwara (OM=01, RBA=01, SC=03) did not join within stipulated period and accordingly their appointment was cancelled vide this office order No. 373 DSEK of 2019 dated 05/03/2019;

Whereas, the matter was taken up with Administrative Department for operation of waitlist vide this office letter No. DSEK/NT/SSB/565/2018/All/1997 dated 13/12/2018 and the Administrative Department vide letter No. Edu-I/615/2018 dated 04/02/2019 conveyed approval for operation of waitlist strictly as per merit under rules;

Whereas, the appointment order under waitlist was accordingly issued vide 454-DSEK of 2019 dated 01/05/2019 in respect of 03 (three) selectees figuring in the wait list (OM=01, RBA=01, SC=01) in District cadre Kupwara;

Whereas, withheld recommendation in favour of Shabir Ahmad Sheikh figuring at S.No.04 (RBA) in District Kupwara was released by J&K SSRB vide letter No: SSB/Secy/Sel/169/2018/666-68 Dated: 22/01/2019 duly forwarded by Administrative Department vide letter No: Edu-I/615/2018 dated: 06/02/2019 and accordingly appointment order in his favour was issued vide No. 354-DESK of 2019 dated: 01/03/2019

Whereas, Mr. Shabir Ahmad Sheikh S.No. 04 (RBA) in District cadre Kupwara did not join within the stipulated time and accordingly his appointment was cancelled vide Order No. 437-DSEK of 2019 dated 22/04/2019;

Whereas, the matter was taken up with the Administrative Department vide letter No. DSEK/NT/SSB/565/2018/Kup/1322 dated 20/08/2019 for operation of waitlist in favour Syed Tariq Ahmad figuring at S.No.02 under waitlist (RBA) in District cadre Kupwara.

Whereas, the Administrative Department vide letter No. Edu-I/615/2018 dated 13/11/2019 forwarded a representation of Aijaz Ahmad Lone S/o Mohammad Akbar Lone R/o Vawoora Lolab District Kupwara figuring at Sr. No. 03 under wait (RBA) and intimated that the selectee at Sr. No 02 under wait (RBA) is not interested to join against the post in the Department as he is already working as Jr. Assistant in Education Department and has provided an affidavit to this effect. It was further instructed to examine the case properly and furnish report in light of the the representation of Aijaz Ahmad Lone S/o Mohammad Akbar Lone R/o Vawoora Lolab District Kupwara;

Whereas, the case was examined and it came to the fore that Mr. Syed Tariq Ahmad (waitlist S.No. 02) under RBA was already working as Junior Assistant at BHS Khahipora Kupwara, who provided his written consent that he has no objection if the candidate figuring at Sr. No. 03 (RBA) under wait is appointed as Jr. Assistant and accordingly the report was submitted to the Administrative Department vide this office letter No. DSEK/NT/SSB/565/2018/1675 dated 07/12/2019 for further necessary instructions;

Whereas, the Administrative Department vide letter No Edu-I/615/2018 dated 03/01/2020 conveyed authorization/permission to operate wait list in favour of candidate namely Aijaz Ahmad Lone S/o Mohammad Akabar Lone R/o Vawoora Lolab District Kupwara, figuring at Sr. No. 03 in the waiting list under RBA category against the post of Junior Assistant in District cadre Kupwara;

Now therefore, sanction is hereby accorded to the provisional appointment of below named **one (01)** candidate as "**Junior Assistant**" in District cadre Kupwara, in the pay level 4 (25500-81100) as admissible under rules.

The appointee shall report to the Chief Education Officer, concerned within a period of 21 days from the date of issuance of this order and shall be allowed to join only on the production of the following documents/certificates (in original) to be verified subsequently.

- Character & antecedents certificate from Additional Director General of Police (CID).
- All Academic/Technical Qualification certificates.
- Permanent Resident Certificate.
- Category Certificate.
- Age and health certificate.
- Discharge certificate from the Institution attending / last attended.
- Certificate from District Industries Centre/Employment Exchange to the effect that no loan under self-employment scheme has been taken.
- Total marks obtained and percentage of the selectee in consonance with merit list authenticated from the original certificates.

The appointment of the appointee shall further be subject to the following conditions: -

- a) That he shall give an undertaking in the shape of affidavit to the effect that:
- i. In case adverse report about her character and Antecedents is received from the Inspector General of Police, (CID), J&K, to whom a reference shall be made by the Chief Education Officer, he shall have no right to claim her appointment as Junior Assistant in Education Department and his appointment as such, shall be deemed to have been cancelled ab-initio.
 - ii. If, on verification, genuineness of the qualification certificates from the concerned issued authority is found that the same is fake/forged, the claim of the appointee for appointment as Junior Assistant shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
 - iii. He will not apply for transfer in any case for a period of five years where he has been adjusted/posted.
- b) The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (i) and (ii) above are received in his favour.
- c) The appointment shall be strictly in terms of SRO 202 of 2015 dated: 30/06/2015 read with Jammu & Kashmir Probationer (Condition of Service, Pay & Allowances) and fixation of Tenure Rules 2020 issued vide S.O.192 of 2020 Dated: 17/06/2020 and G.O. No: 654-JK (GAD) of 2020 Dated: 19/06/2020
- d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 Dated: 24/12/2009.
- e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice in light of Circular instructions issued by GAD vide No. 08-JK (GAD) of 2019 dated 04/12/2019

The appointment of the candidate shall be subject to outcome of any writ petition(s), if any, pending in any Court of competent jurisdiction or any order which may not be presently within the knowledge of this Directorate.


