Whereas, out of the total sanctioned strength of 24 posts of Section Officers of School Education Department (Kashmir Division), 20 posts are vacant; and

Whereas, the post of Section Officer holds the pivotal position in the clerical hierarchy and the unavailability of incumbents has significantly hampered smooth functioning of various offices/ institutions of the Department; and

Whereas, in terms of J&K School Education (Subordinate) Service Recruitment Rules, 2008 the candidates having three years of service as Head Assistants are eligible for promotion as Section Officers; and

Whereas, 14 Head Assistants working in the department shall complete three year substantive service as Head Assistants within next six months and as such shall become eligible for promotion as Section Officer.

Now, therefore, in view of the above, it is hereby ordered that following Head Assistants of the J&K School Education (Subordinate) Services shall look after the routine work of the post of Section Officers, till the post are filled up on regular basis:-


