Now, therefore, the deputation of fourteen Fourteen (14) in-service un-trained graduate Teachers (as per annexure to this orde) who were deputed to under go B.Ed (Regular) course during *session 2022-24* at the Govt College of Education, (IASE) Srinagar vide above referred order, is hereby cancelled, ab-initio.


