Subject:- Placement of PG Masters/ Teachers as I/C Lecturers in the discipline of Computer Science.

Government Order No.:- 581 - Edu of 2015

Dated :- 30 -10-2015

On the basis of seniority/ eligibility, the P.G. Masters/ Teachers figuring in the Annexure "A" are hereby placed as I/C Lecturers in the discipline of Computer Science in their own pay and grade with charge allowance as admissible under rules for a period of six months or till the posts are filled up on regular basis, whichever is earlier. These placements, however, shall not confer any superior claim or right upon them at the time of their confirmation and shall also be subject to the outcome of any court case that may be sudjudice in the court(s) of Law.

The I/C Lecturers shall report to concerned Directorate of respective divisions for further posting/ adjustment within 21 days from the date of issuance of this order. Any I/C Lecturer who fails to join within the stipulated period of time, it shall be presumed that he/she has foregone the elevation and his/her placement as I/C Lecturer shall be withdrawn without any further notice.

The case of those PG Masters/ Teachers who have done post graduation through distance mode will be considered after verification of their documents and fulfillment of criteria laid down vide Government Order No. 252-HE of 2012 dated 30-12-2012.

The concerned Directorate of School Education will allow them to join only after verifying the following:-

- (i) The bio-data/ service particulars of the promotees as mentioned against each.
- (ii) Any of the promotee who has already been working either as I/C Headmaster or I/C Lecturer in other discipline may not be allowed to join as I/C Lecturer (Computer Science).
- (iii) That the in-service candidates who have acquired P.G Degree after availing the leave during his/her service and after obtaining the proper permission from the competent authority. In case during this verification, it is proved that they have failed to obtain the permission from competent authority or they had not availed proper leave, their officiating placement shall be deemed to have been cancelled ab-initio. The Director School Education shall immediate revert him back to his original place of posting.
- iv) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which acquired are valid and validity of category certificate(s), if any, shall be determined by the concerned Directorate of School Education.

- The officer(s) is not involved in any adverse case(s) (Vigilance/Crime etc) which fact shall be ascertained by the concerned Directorate of School Education.
- vi) The placement is without prejudice to the outcome of any writ petition pending in any competent court(s) of law or any case pending in Viailance or Crime Branch.

The concerned Directorate of School Education Department shall ensure that all the above conditions are fulfilled by an Official before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by an Official, he/she will not be allowed to joins and such cases shall be referred to Administrative Department for further action.
