Whereas, the teacher was again provided opportunities by this office on 06/07/2021 (through a joint show cause notice), wherein he was asked to present himself before this Directorate along with statement of defense within 07 days failing which action as warranted under rules shall be initiated against him without serving any further notice; and

Whereas, neither the teacher again presented himself before this Directorate nor responded to these notices, indicating thereby that he is not interested to work in the Department; and

Whereas, un-authorized absence from duties attracts action as warranted in terms of article 113 of J&K Civil Services Rules (Volume I) of 1956, which reads as under:-

Article 113

"After five years of continuous absence on leave an officer is considered to be out of state employee."

Whereas, the issue was placed before the Designated Committee in its meeting held on 11/12/2021 and after examining the case the committee took the following decision:

"Process for termination under Article-113 J&K CSR of 1956".


