**Subject :- Confirmation of Incharge Masters as Masters.**

Whereas, Smt. Pushp Lata Tickoo Ex-Teacher Migrant Cell Jammu was placed as I/C Master in her own pay and grade prospectively and was posted in District Srinagar on an available post provided she will join/serve in valley physically pending ratification by the DPC, vide this office Order No. 1052 DSEK of 2009 dated 27/08/2009; and

Whereas, after issuance of said placement order the official was temporary transferred to Jammu province on security grounds retaining lien and promotion prospectus in her parent Divisional Cadre Kashmir by the Administrative Department vide Govt. Order No. 681-Edu of 2009 dated 10/09/2009; and

Whereas, the official could not project/process her case for confirmation as Master due to unknown reasons as a result of which she continued to work as I/C Master in her own pay and grade; and

Whereas, the Director School Education Jammu vide his communication dated 29/12/2018 forwarded the case of official for confirmation as Master to this office but the case remained under correspondence; and

Whereas, the issue was placed before the Divisional Departmental Promotion Committee in its meeting held on 19/08/2021 (Agenda Item No. 03) and the committee after threadbare discussion took the following decision:-

*"The DDPC has decided to consider the confirmation as Master in the Pay scale of Rs 35900-113500, notionally from the date she was elevated as Master and monetary benefit with effect from 01/12/2017."*

Now, therefore, pursuant to the decision of the Divisional Departmental Promotion Committee, sanction is hereby accorded to the confirmation as Master in favour of Smt. Pushp Lata Tickoo who was placed as Incharge Master vide this office Order No. 1052 DSEK of 2009 dated 27/08/2009 in the Pay Structure of Rs 35900-113500, notionally from the date of placement as Incharge Master and monetarily w.e.f. 01/12/2017, without pre-judice to the outcome of writ petition if any pending before competent court of law which is not within the knowledge of this Directorate.

The confirmation order shall be subject to fulfillment of all conditions as laid down in the confirmation order No. 1512 DSEK of 2018 dated 22/12/2018.


