Whereas, the Administrative Department vide letter No. Edu-I/401/2014 dated 02.02.2015 forwarded the list of 800 candidates selected as Teachers for District Cadre Baramulla pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/2014/2955-61 dated 19.12.2014 and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;

Whereas, among others the selection in respect of (02 and 48) candidates was kept withheld for want of some clarification and has now been recommended by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/1720-21/15 dated 06/02/2015 and No. SSB/Sel/Secy/2015/2494-95 dated 24/02/2015 and No. SSB/Sel/Secy/2015/2496-97 dated 24/02/2015 forwarded by the Administrative Department vide communication No. Edu-I/145/2014 dated 10/02/2015 and No. even dated 04/03/2015 for their appointment as Teacher District Cadre Baramulla under various categories;

Whereas, the Administrative Department in their earlier communication No. Edu-I/286/2012 dated: 05.09.2012 conveyed guidelines to issue the provisional appointment orders in favour of the selectees after obtaining the undertaking on the devised format with the following explicit conditions:-

- The salary in favour of the selected candidates is only drawn:-
- After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;

- After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate;
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed)
- If on verification the certificates produced by the appointee are proved fake/forged, the
  appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be
  initiated against the candidates.
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the Judicial Magistrate.

Whereas, in light of above instructions of the Administrative Department (43+209+285 = 537) Five Hundred Thirty-seven (Out of 576) selectees furnished their undertakings on the devised format duly attested by the 1<sup>st</sup> Class Magistrate before the Chief Education Officer Baramulla, as intimated vide his No. Estt/Tr/15610 dated 23.03.2015 for for issuance of provisional appointment orders in their favour in response to DSEK's notification No.

DSEK/Estt/III/B-Trs/05/2015/Sel-Bla/4567-68 Dated 05/03/2015 and No. DSEK/ LSH/III/B-Trs/05/2015/Sel-Bla/4581-83 Dated 07/03/2015;

Whereas, after scrutinization of particulars, some discrepancies were noticed in the selection list in respect of Eight (08) candidates whose provisional appointment shall be on adered only after clarification is received from the Administrative Department;

Now, therefore, sanction is hereby accorded to the provisional appointment of (43+203+283 = 529) Five Hundred Twenty-nine candidates as Teachers in District Cadre Baramulla against the available slots in various categories as per the Annexu en to this order in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 for Graduates and above and Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009. The caudidate are required to report to the Chief Education Officer, Baramulla by or before 12th April 2015 for further posting.

The Chief Education Officer, Baramulla shall allow the candidates to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (Ciri)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Age and health certificates
- Discharge certificate from the Institution attending/last attended
- Certificate from the concerned authority to the effect that no loan under-self en playment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment orders of the candidates shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no stary till issuance of such orders shall be drawn.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court.
