#### Terms and conditions:

- 1. The engagement shall be made purely on "Academic Arrangement" at +2 level on monthly consolidated honorarium of Rs. 7000/- (Rupees Seven thousand only) per month for the session-2017.

The candidates applying for the engagement as Lecturers at +2 level under the dispensation of "Academic Arrangement" for the academic session-2017 shall deposit an amount of Rs. 100/= as examination fee alongwith the application form. The tentative date of examination (Written test) is 19-02-2017. The venue will be Srinagar at various Educational Institutions which shall be notified later on. The complete applications on the prescribed format along with affidavit duly sworn in and attested by the Ist Class Judicial Magistrate as per enclosed prescribed formats can be downloaded from this office website (www.dsek.nic.in) or can be had from the concerned Chief Education Officer. A candidate can appear in only one subject.
