Whereas, vide order No. 383-DSEK of 2020 dated 12/11/2020, this Directorate issued provisional appointment order in favour of 10 (ten) candidates in whose favour recommendation was made in the original selection list by J&K Service Selection Board;

Whereas, recommendation in respect of 30 (thirty) selected candidates was subject to "verification of computer diploma and recognition status of the computer institute viz-a-viz the prescribed qualification by the indenting Department/appointing authority";

Whereas, the matter in respect of these **30 (thirty)** candidates was referred to Administrative Department vide this office letter No. DESK/NT/Mig-R/26-31/SF/2020/850 dated 21/11/2020, No. DSEK/NT/Mig-R/26-31/SF/2020/851 dated 23/11/2020 and No. DESK/NT/Mig/R/2631/SF/2020/955 dated 09/12/2020 for seeking necessary verification/clarification/instructions;

Whereas, Administrative Department vide letter No. Edu-I/88/2020 dated 24/12/2020 conveyed directions of the competent authority to issue appointment orders in favour of these selected candidates within seven days and take further action to verify the status of recognition/affiliation of such private computer institutes from the concerned institutes;

The appointee shall report to this Directorate within a period of 21 days from the date of issuance of appointment order. In case the appointees do not join within the stipulated period their appointment shall be deemed to have been cancelled ab-initio without any further notice.

The appointees shall be allowed to join only on production/checking/verification of the following certificates in original.

- 1. Academic/Technical Qualification certificates.
- 2. Matriculation/Date of Birth certificates.
- 3. Health Certificate issued by Chief Medical Officer.
- 4. Permanent Resident Certificate issued by the Competent Authority
- 5. Certificate from the concerned authorities to the effect that no loan under the self employment scheme has been taken by the appointee concerned.
- 6. Migrant Registration Certificate
- 7. Category certificate (if any)
- 8. Disability certificate (if any)

## The appointment of the above candidates shall further be subject to the following conditions:-

- 1. Each appointee shall execute an agreement in the "form "prescribed under Jammu and Kashmir Migrant (Special Drive) Recruitment Rules, 2009, issued under notification SRO 412 of 2009 dated 30/12/2009;
- 2. Each appointee shall give an undertaking duly attested by First Class Magistrate in the shape of an affidavit to the effect that in case an adverse report about his/her academic/technical/category certificates wherever applicable and also character and antecedents is received from concerned issuing agencies/Inspector General of Police (CID)to whom a reference shall be made by concerned within whose jurisdiction he/she is posted, he/she shall have no right to claim his/her appointment as "Junior Assistant" as such shall be deemed to have been cancelled ab-initio.
- 3. If on verification the certificates produced by the appointee are proved fake or forged, the appointment shall be deemed to have been cancelled ab-initio.
- 4. Salary of the appointee shall not be drawn and disbursed unless satisfactory character and antecedents report is received from ADGP, CID J&K and verification of relevant certificate/documents is received from the concerned authorities.
- 5. The appointment order shall be governed under new pension scheme as per SRO-400 dated 24/12/2009
- 6. The appointment of the candidates as "Junior Assistants" shall be subject to outcome of the writ petition(s) if pending any court of law, which may not be immediately within the knowledge of this Directorate.
- 7. Their inter-se seniority of the appointees shall be in the order of merit of the J&K Service Selection Board;

8. The appointees shall be on probation for a period of 02 years.
