Subject:- Grant of promotion In-Situ of Higher Standard pay scale.

As recommended by the Departmental Committee, Sanction is hereby accorded to the grant of (In-Situ) promotion to the Higher Standard Pay Scale in terms of J&K Civil Services (Higher Standard Pay Scale Scheme Rules 1996 and SRO-14 Dated.15.01.1996), in favour of **69 (Sixty nine)** Non teaching / Class-Iv officials, in the corresponding pay scale / pay band/ grade pay from the date as indicated against each in the Annexure to this order, on notional basis from the date they are eligible and with monetary benefits w.e.f. 1st February, 2014, in terms of rules 2.43 of Financial Code Vol-I.

The promotion In-situ to the higher standard pay scale in favour of the non-teaching/ Class-Iv Officials, whose detailed particulars are indicated in the annexure is granted/ released subject to the fulfilment of the following conditions.

1. That the Chief Education Officer / Drawing and disbursing officer concerned will verify the particulars of each official with reference to his/ her original services records before allowing (In-Situ) promotion benefit and he shall be personally responsible for correctness of the particulars of the employees working under him. In case any variation is noticed in the particulars of any such official, the benefit of the in-situ promotion shall not be released and the case referred to this Directorate for further orders/ clarification.
2. That the incumbents have completed required spell of 09/18/27 years as the case may be satisfactorily and without any interruption as defined in rules 4(K) of SRO-14, Dated.15.01.1996.
3. That the incumbents were not under suspension or contemplated in any charge or charge sheeted under classification Control and Appeal Rules 1956 or any other rules and his/her work and behaviour has remained satisfactory.
4. That the present promotion In-Situ shall not change/ affect the existing designation/ seniority/ duties of the employees.
5. That the benefit of the promotion in-Situ shall not be applicable, if the official has earlier foregone regular / functional promotion or will forego his functional promotion in future.
6. That the work and behaviour of the officials has remained satisfactory during the preceding 03 (three) years.
7. That before implementing the order, the concerned CEO shall ensure that the employees are holding substantive appointment and his/ her appointment is genuine, before endorsing this order to sub- office for implementation.
8. That no time bound promotion has been accorded by the DDO/CEO at his own level in favour of any employee.
9. In-case, if it has been found that the time bound promotion has been sanctioned in favour un- regularized Migrant substantive/ contractual by virtue of this order, the same should not be given effect.
10. Consequent upon on grant of HSP's has/ have granted shall be regulated strictly in accordance to the provisions laid down in SRO-14 and SRO-94 dated.15-04-2009 and Govt. Order No.07-F and Govt order No.08-F dated.18/01/2011 read with SRO-42 dated.02/02/2011 and govt Order No.238-F of 2011 dated.30.09.2011 in addition rules 2.43 of F.C Vol-I be also implemented while Implementation of the (In-Situ) promotion order.
11. It shall be personal responsibility of the concerned Chief Education Officers to verify the particulars of each employee and observance of all Codal formalities and conditions mentioned herein above and the DDO's concerned shall give effect/ draw the arrears on account of time bound promotion after getting the entries to this effect recorded in the service book, , duly countersigned by the Concerned Chief Education Officers.
12. The insitu promotion in respect of **non teaching/ Class-IV officials**, are release, subject the upto date verification is got recorded in their service books by the DDO, before giving effect to this order.
13. The In-situ promotion in respect of Mr Gh. Hassan Wani, Rtd. I/C Head Assistant ZEO's Office Wagoora District Baramulla and MR. Mohd Ashan Dar, Rtd. Senior Assistant Zonal education Office, Shadimargh District Pulwama, are released subject to the producing of affidavit by the officials duly attested by Judicial Magistrate to the effect that in the event of their confirmation as Sr. Asstt. recovery of excess pay shall be made.




