Whereas, the Administrative Department vide letter No. Edu-I/401/2014 dated 02.02.2015 forwarded the list of 800 candidates selected as Teachers for District Cadre Baramulla pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/2014/2955-61 dated 19.12.2014 and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;

Whereas vide this office Notification No. DSEK/Estt/III/B-Trs/05/2015/Sel-Bla/4567-68 dated 05.03.2015 followed by many such notifications published from time to time, these selectees were advised to submit their undertakings on the devised format and accordingly provisional appointment orders were issued in their favour;

Whereas, the Chief Education Officer, Baramulla vide letter No. CEO/Bla/27162 dated 14.11.2015 intimated that the two (02) candidates namely 1) Firdous Maqbool Mir S/o Mohd Maqbool Mir R/o Mir Mohalla Adipora Sopore figuring at S.No. 1 to Annexure of DSEK Order No. 2524-DSEK of 2015 Dt: 07.10.2015 (SSBS.No. 1/Wait, Item 256 of Notification 03 of 2012)) under OM Category, and Deep Kumar S/o VedParkash R/o PO BasantGarh, Teh-Ramnagar District Udhampur figuring at S.No. 23 to the Annexure of Order No. 2524-DSEK OF 2015 Dt: 07.10.2015 (SSBS.No. 5/Wait, Item 447 of Notification 05 of 2013) under SC Category, have failed to join the Department so far and have furnished their undertakings (duly countersigned by the 1st Class Magistrate) to the effect that they don't have any objection if the next in merit candidates are considered against their posts;

Whereas, due to non-joining of above named two candidates, two vacancies (**01/OM** againstItem 256, 03 of 2012 **and 01/SC** against Item 447, 05 of 2013) became available for operation of wait list;

Whereas, ALTAF RASHID KAKROO S/o ABDUL RASHID KAKROO figuring at S.No. 10/Wait and ARJUN KUMAR S/o DARSHAN LAL R/o GANDHARWAN AKHNOOR, JAMMU figuring at S.No. 6/Wait under SC Category are in queue as per merit position in wait list. However, Mr. ALTAF RASHID KAKROOhas furnished an undertaking duly attested by the 1st Class Magistrate that he is already working in Police Department and shall have no objection if the next in merit candidate is considered against his post. As such the candidature of AB RASHID PARA S/o MOHDMAQBOOL PARA R/o ADIPORA, SOPORE, BARAMULLA-figuring at S.No. 11/Wait under OM Category falls in next of merit in queue against Item 256 (03 of 2012) for provisional appointment as Teacher in District Cadre Baramulla.

Whereas, the Administrative Department vide letter No. Edu-I/401/2014 dated 18.11.2015 forwarded SSB's communication No. SSB/Sel/Secy/2015/11139-41 dated 21.10.2015 wherein the recommendation in respect of Shams U Nisa D/o Bashir Ahmed Pode figuring at S.No. 12 under ST Category at item No. 447 (05 of 2013) has been released for favour of further necessary action.

Whereas, the Administrative Department in their earlier communication. No. Edu-I/286/2012 dated: 05.09.2012 conveyed guidelines to issue the provisional appointment orders in favour of the selectees after obtaining the undertaking on the devised format with the following explicit conditions:-

The salary in favour of the selected candidates is only drawn:-

- After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;
- After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate:
 - The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed).



 If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated against the candidates.

Whereas, in light of above instructions of the Administrative Department **Two (02 out of 03)**candidates furnished their undertakings on the devised format duly attested by the 1st Class Magistrate in response to this office notification No. Estt-III/B-Trs/67101-04 dated 09.12.2015;

Now, therefore, sanction is hereby accorded to the provisional appointment of **Two (02)**candidates (Detailed below) as Teachers District Cadre Baramullaagainst the available slots in various categories in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 for Graduates and above and Under–Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidates are required to report to the Chief Education Officer, Baramulla by or before **15**th January, **2016** for further posting.

 - Qualification certificates viz Degree/Marks
 - · Permanent resident certificates
 - · Age and health certificates
 - Discharge certificate from the Institution attending/last attended
 - Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
 - Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
 - total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate

The formal appointment orders of the candidates shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court.
