Whereas, the Administrative Department vide letter No. Edu-I/77/2017 dated: 17.04.2017 and No. Edu-I/186/2017 dated: 10.07.2017 forwarded the selection list of **203 & 40** candidates selected as Teachers, under Prime Minister's Special Package for Kashmiri Migrants, for District Cadre Srinagar and Budgam respectively for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/1206-12 dated 25.01.2017 and No. SSB/Secy/Sel/2017/2668-74 dated 08.03.2017 against Notification No. 01 of 2012 dated 19.07.2012 against item No. 013 and 037;

Whereas, the Administrative Department vide letter No. Edu-I/186/2017 dated 11.06.2018 forwarded SSB's Order No. 772-SSB of 2017 dated 27.12.2017 whereunder selection in respect of **Rahul Raina S/o Rattan Lal Raina** has been released and has been placed at S.No. **3/Wait** (revised from earlier S.No.45) under **OM Category** in District Cadre **Budgam** in view of the fact that Two points of Graduation have been deducted from his overall merit (49.0278-2=47.0278) as his Graduation Degree from KUSSK has not been considered under the purview of Govt. Order No. 252-HE of 2012 dated 30.05.2012, consequently, the candidate earlier figuring at S.No. 46 under OM Category shall now figure at S.No. 45 under OM Category so on and so forth upto S.No. 3/Wait under OM Category who shall now figure at S.No. 2/Wait.

Whereas, due to non-joining of **07** candidates, **Rahul Raina S/o Rattan Lal Raina** who now makes place in the selection zone at S.No. **3/Wait** under OM Category in District Cadre Budgam and in terms of approval conveyed by the Administrative Department vide letter No. Edu-I/186/2017, dated 23.03.2018 this office operated wait list against the slots which became available due to non-joining of candidates;

Whereas, in another communication of Administrative Department bearing No. Edu-I/77/2017 dated 28.06.2018, the selection in respect of **Meenakshi Tickoo D/o Rattan Lal Tickoo W/O Anil Razdan** figuring at **S.No. 154** in District Cadre **Srinagar** has been released vide SSB's No. SSB/Secy/Sel/Mig/Sgr/XVIII/2584-86 dated 09.03.2018.

Whereas, vide this office notification No. DSEK/Estt/III/B-Trs/ PMP/017/2535-39 dated 10.07.2018, the above selectees, were asked to deposit their undertakings and agreement on the devised format duly attested by the 1<sup>st</sup> Class Magistrate in terms of SRO-412 of 2009 dated 31.12.2009 alongwith all original certificates/testimonials with a set of self attested Xerox copies within **Ten (10) days** from the date of publication of the notification;

Whereas, in response to the above notification dated 10.07.2018, both the candidates deposited the requisite papers in this Directorate, for issuance of provisional appointment order in their favour;

Now, therefore, in continuation to this office Order No. 1135-DSEK of 2017, dated 12.09.2017, and No. 881-DSEK of 2017 Dated 28.07.2017, sanction is hereby accorded to the provisional appointment of **Two** candidates (whose detailed particulars are reproduced below) as **Teacher** in **District Cadre Budgam/Srinagar** against the additional posts created under Prime Minister's Special Package for Kashmiri Migrants in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 (Pre-revised) admissible under SRO-93 dated 15.04.2009. The candidates are required to report to the concerned Chief Education Officers, within **Twenty-one (21) days** from the date of issuance of this appointment order for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities.

The provisional appointment shall be subject to the following conditions:-

- The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled abinitio and he/she shall have no claim of his/her appointment.
- The verification of qualification certificates/reserved category certificate (wherever applicable) from the concerned issuing authority.

The Chief Education Officer, concerned shall allow the candidate to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Migration Certificate whereunder eligible for seeking employment under Prime Minister's Special Package for Kashmiri Migrants.
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointee shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the district under any circumstances. In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the action of his /her migration, in terms of the agreement executed by each appointee under SRO-412;

The seniority of the appointees shall be fixed at the places on the posts of their first appointment in that particular grade/service. The provisional appointee shall be on probation initially for a period of Two years.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court which are not immediately within the knowledge of this Directorate.
