As recommended by the committee constituted vide Order No 472-DSEK of 2017 Dt.16.02.2017 sanction is hereby accorded to the appointment of Miss. Ruheela Qounsar Wani D/o Gh Mohammad Wani & Late Hamida (Deceased Lib. Bearer) BHS Humhama Budgam R/o Guzarbal Chattabal District Srinagar on Compassionate grounds as Class-IV (library Bearer) in the pay scale of Rs. 4440-7440 with grade pay of Rs 1300/= (pre-revised) against the post in BHS Humhama Zone Budgam. The appointee shall be on probation for a period of two years.

The appointee shall be allowed to join only after production/ verification of the following certificates in original:

- Age and health certificate
- ii. Educational qualification certificate (from recognized / Board/ University)
- Character/ Antecedents Certificate. iii.
- iv. Date of Birth Certificate
- Permanent Resident Certificate V.
- No Loan Certificate νi.
- Affidavit duly Sworn in before Judicial Magistrate to the effect that in the event of vii. his failure to look after the deceased's family his appointment shall be cancelled.
- If on verification, the certificates produced by the appointee are proved fake or viii. forged, the appointment shall be cancelled ab-initio.

In case the appointee fails to join and produce the certificates within 21 days from the date of issue of this order, the order will cease to operate without any further notice to the appointee. The candidate be allowed to join provisionally in absence of verification of her character/ antecedents is received from the CID. However, his pay shall not be drawn and paid till the verification of her character/ antecedents is received from the CID. In case of adverse report from the CID, the order will be deemed to have been cancelled & will have no claim for Salary for the period he worked, and an undertaking to this effect be also obtained from her for record and reference.
