Subject: Inter district transfer of Senior Assistant.

Whereas, the General Administration Department vide OM. No. GAD(Adm)65/2012-I, dated 10/07/2012, has issued instructions with regard to transfer/adjustment of officials who have been appointed against district cadre posts in the erstwhile districts and are posted in newly-created districts, and vice versa read as:

"the issue as to which district cadre (undivided District or the Districts created in 2006) a particular employee belongs was referred to the General Administration Department by Education Department. Some employees, who reside within the territorial jurisdiction of a newly created district were a part of the district cadre of the undivided district. The question whether such employees should be treated as a part of district cadre of erstwhile district or newly created district has been examined in General Administration Department. The matter has to be decided on the basis of domicile factor i.e, if any official has been/is residing within the territorial jurisdiction of the newly created district, he shall be treated as part of the district cadre of the newly created district. Similarly if an employee has/is residing within the left over territorial jurisdiction of the old district (after carving out of new district), he shall be treated as part of the district cadre of erstwhile/old district".

Whereas, Mr. Ghulam Hassan Teli, Senior Assistant ZEO's Office Gurez, Bandipora R/O Dangerpora Pattan, District Baramulla has requested for transfer to his home district Baramulla on the plea that he was appointed in the year 1991 in Erstwhile District Baramulla, and was posted at HS Gadkhod Sonawari, in the year 2007 when District Baramulla was bifurcated and New District, Bandipora was carved out from Erstwhile District Baramulla and the HSS, Gadkhod Sonawari came within the Administrative jurisdiction of district, Bandipora;

Whereas, inter District transfer case of Mr. Ghulam Hassan Teli, Senior Assistant ZEO's Office Gurez, Bandipora was forwarded to the Admn. Deptt. Vide letter No. DSEK/NT/Trans/02/2216/Bpr/1867, dated. 04/10/2016 and No. DSEK/NT/Trans/02/2016/All/1906, dated. 30/11/2017;

Whereas, the Admn. Deptt. vide letter No. Edu-I/503/2016, dated. 19/07/2018, has instructed to settle the transfer issue of the official namely Ghulam Hassan Teli, Sr. Assistant, ZEO's Office Gurez, Bandipora in light of directions of the GAD issued in this regard.

Now therefore, in view of the above Mr. Ghulam Hassan Teli, Sr. Assistant, ZEO's Office Gurez Distt. Bandipora is transferred to District Baramulla and adjusted in HSS, Hardushora, on the available post.

However, the Chief Education Officer, Bandipora/DDO concerned before relieving the transferee shall ensure that he is holding genuine appointment on substantive post and is not involved in any departmental inquiry fraud/FIR/VOK/Suspension/case. Further, Chief Education Officer, Bandipora, may provide substitute before implementing this order.
