Whereas, in pursuance to the recommendations of the Divisional Departmental Promotion Committee, Mr. Imtiyaz Ahmad Sofi and Mr. Zubair Ahmad Wani, Junior Scale Stenographers have been promoted as Senior Scale Stenographers w.e.f 01/10/2017 and 01/04/2020 (on notional basis and prospectively on regular basis) respectively, vide this office Order No. 09- DSEK of 2021 Dated 11-01-2021; and

Whereas, in response to the General Administration Department's O.M. No. GAD-ESTB/33/2021-07-GAD dated: 27/01/2023, the information/documents in respect of Senior Scale Stenographers of the Kashmir Division were submitted office vide this Department Administrative

DSEK/NTS/72/2023/465-66 dated:- 13/02/2023; and

Whereas, General Administration Department vide communication No. GAD-ESTB/33/2021-07-GAD dated: 03/10/2023 sought clarification for effecting the retrospective promotion of Mr. Imtiyaz Ahmad Sofi and Mr. Zubair Ahmad Wani, Junior Scale Stenographers w.e.f 01/10/2017 and 01/04/2020 respectively, issued vide this Office Order No. 09-DSEK of 2021 Dated 11-01-2021; and

Whereas, the case was again placed before the Divisional Departmental Promotion Committee convened on 23/11/2024 and the Committee after threadbare discussion and scrutiny of the documents, recommended as under:-

"The Promotion Order in respect of Mr. Imtiyaz Ahmad Sofi and Mr. Zubair Ahmad Wani as Senior Scale Stenographer bearing No: 09-Zubair Ahmad Wani as Senior Scale Stenographer bearing No: 09-DSEK of 2021 dated: 11/01/2021 (who were actually eligible for such promotion w.e.f. 11/01/2021) has been issued in violation of Govt. Order No. 743-GAD of 2007 dated:-28/06/2007. Therefore, the Committee decided that necessary Corrigendum to this office Order No: 09-DSEK of 2021 dated: 11/01/2021 with regard to date of promotion as 11-01-2021 be issued in light of Govt. Order No. 743-GAD of 2007 dated 28-06-2007"

Now therefore, in view of the above, and as recommended by Divisional Departmental Promotion Committee in its meeting held on 23-11- 2024, the date of Promotion of Mr. Imtiyaz Ahmad Sofi and Mr. Zubair Ahmad Wani as Senior Scale Stenographers is reckoned with effect from "11/01/2021" instead of 01/10/2017 and 01/04/2020, respectively.
