Whereas, the Administrative Department vide letter No. Edu-I/77/2017 dated: 17.04.2017 forwarded the selection list of Two-hundred Sixty-five (265) candidates selected as Teachers, (203 for District Cadre Srinagar and 62 for District Cadre Baramulla) under Prime Minister's Special Package for Kashmiri Migrants, for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/1206-12 dated 25.01.2017 and No. SSB/Secy/Sel/2017/1213-20 dated 25.01.2017 against Notification No. 01 of 2012 dated 19.07.2012, Item No's 037 & 009 respectively;

Whereas, out of 265 candidates, 30 posts in District Cadre Srinagar and 27 posts in District Cadre Baramulla have been kept reserved in pursuance to the Hon'ble Court direction passed in SWP No. 1975/2014 dated 26.08.2016 and recommendation in respect of 92 candidates of District Cadre Srinagar & 15 candidates of District Cadre Baramulla has been kept withheld by the SSB for certain clarification;

Whereas, the SSB vide various communications (detailed below) conveyed by the Administrative Department vide letter No. Edu-I/77/2017 dated 14.06.2017 and No. even dated 01.06.2017 released the selection of 23 candidates including 5 candidates from the waiting list;

Whereas, the Administrative Department vide letter No. Edu-I/56/2017 dated 04.08.2017 forwarded SSB's communications No. SSB/Secy/Sel/Mig/Sgr/VII/2017/5678-80 dated 30.06.2017, No. SSB/Secy/Sel/Mig/Sgr/XII/2017/5549-51 dated 16.06.2017, No. No. SSB/Secy/Sel/Mig/Sgr/XII/2017/5527-29 dated 16.06.2017 and No. SSB/Secy/Sel/2017/5086 dated 05.06.2017 whereunder the selection in respect of 03 Candidates from District Cadre Srinagar has been released;

Whereas, vide SSB's Order No. 168-SSB of 2017 Dated 19.04.2017, the position of Amit Koul S/o Prediman Krishen Koul earlier figuring at S.No. 83 under OM Category has been changed from S.No. 83 to S.No. 104, owing to the fact that he furnished an affidavit whereunder he withdrawn his Graduation Degree and consequently his merit position was changed from 49.500 to 47.500 as 2 points were deducted from his overall merit. Consequently, the candidate earlier figuring at S.No. 84 under OM Category shall now figure at S.No. 83 under OM Category so on and so forth upto S.No. 104;

Whereas, notification in respect of these **Twenty (20)** candidates was published in leading newspapers through Information Department vide No. DSEK/Estt/III/B-Trs/6250-54 dated 27.07.2017 and No. DSEK/Estt/III/B-Trs/PMs Package/2017/6475-79 dated 19.08.2017 directing the candidates to furnish their testimonials and undertakings alongwith agreements on the devised format duly attested by the 1st Class Magistrate in terms of SRO-412 of 2009 dated 31.12.2009;

Whereas, in response to these notifications, **Seventeen (17) candidates (15/Srinagar & 02/Baramulla)** submitted their certificates/documents in the Directorate of School Education Kashmir, within the stipulated period and **Three (03)** candidates failed to deposit their documents within the stipulated period;

Whereas, while corross checking the documents some variation was found in address against **S.No. 94 and S.No. 138** in District Cadre Srinagar which needs further clarification from the Administrative Department;

Now, therefore, sanction is hereby accorded to the provisional appointment of **Fifteen (15) candidates, (13/Srinagar & 02/Baramulla)** as Teachers in District Cadre Srinagar and Baramulla against the additional posts created under Prime Minister's Special Package for Kashmiri Migrants as per the Annexure to this order in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 for Graduates and above and Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidate are required to report to the Chief Education Officer, **Srinagar/Baramulla** within **Ten (10)** days from the date of issuance of this appointment order for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities.

The provisional appointment shall be subject to the following conditions:-

- A) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to who a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled abinitio and he/she shall have no claim of his/her appointment.
- B) The verification of qualification certificates/reserved category certificate (wherever applicable) from the concerned issuing authority.

The Chief Education Officer, concerned shall allow the candidates to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Migration Certificate whereunder eligible for seeking employment under Prime Minister's Special Package for Kashmiri Migrants.
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment orders of the candidates shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointee shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the district under any circumstances. In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the acton of his /her migration, in terms of the agreement executed by each appointee under SRO-412;

The seniority of the appointees shall be fixed at the places on the posts of their first appointment in that particular grade/service.

The provisional appointee shall be on probation initially for a period of Two years.




