Whereas, the Administrative Department vide letter No. Edu-I/227/2016 dated 30.06.2016 forwarded the list of **55** candidates selected as Teachers in District Cadre **Srinagar** pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Secy/Se//2016/12667-73, dated 11.05.2016 against SSB's notification No. 03 of 2014 under item No. 328;

Whereas, out of these **55** selectees, **06** candidates (02/RBA, **01/ST** & 03/SC) failed to join the Department even after given final opportuninty vide this office notification No. DSEK/Estt/B-Trs/Sel/3062-63 dated 19.01.2017 :

Whereas, in terms of the approval conveyed by the Adminstrative Department vide: communication No. Edu-I/227/2016 dated 22.03.2017, waiting list was operated against the slots which became available due to non-joining of some selected candidates;

Whereas, among other candidates from the wait list, selection in respect of WAHEED ABBAS MUGHAL S/o MAQBOOL HUSSAIN MUGHAL R/o GOGJI BAGH SRINAGAR figuring at S.No. 1/Wait under ST Category, (who made place in the selection zone due to non-joining of one of the candates against ST Category) was kept withheld by the SSRB for want of certain clarification, as such appointment order could not be issued in his favour;

Whereas, vide Government Order No. 504-Edu of 2017 dated 07.08.2017 issued by Administrative Department under endorsement No. Edu-I/227/2016 dated 07.08.2017 whereunder approval for extension of operating wait list upto 31.08.2017, i.e. beyond the date of its expiry viz; 10.05.2017 has been accorded in respect of 01 candidate under ST Category whose selection was released by the Secretary Services Selection Board vide communication No. SSB/Sel/Secy/69/2016/4718-20 dated 0905.2017;

Whereas, accordingly a notification bearing No. DSEK/Estt/III/B-Trs/6494 dated 23.08.2017 was issued in respect of above named candidate for submission of documents in this Directorate within a period of Seven days;

Whereas, in response to this office notification dated 23.08.2017, the said candidate (WAHEED ABBAS MUGHAL) furnished his undertaking duly countersigned by the 1st Class Judicial Magistrate alongwith all original testimonials in the Directorate within stipulated period of Seven days, from the date of publication of the notification.

Now, therefore, in view of the above circumstances, sanction is hereby accorded to the provisional appointment of Waheed Abbas Mughal S/O Maqbool Hussain Mughal R/O Gogji Bagh Srinagar Figuring At S.No. 1/Wait Under ST Category as Teacher in District Cadre Srinagar in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 for Graduates and above and Rs.2400 for Under-Graduates, admissible under SRO-93 dated 15.04.2009. The candidate is required to report to Chief Education Officer Srinagar within Ten (10) days from the date of issuance of this appointment order for seeking further posting on his own risk and responsibility till the verification/authentication of all relevant



documents/certificates are received from the concerned issuing authorities. The appointment shall be subject to the following conditions:-

- i. The appointees/selectee shall be on probation for a period of two years.
- ii. The appointees shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009.
- iii. In case, at any stage it emerges that the certificates/any relevant document furnished /produced by the selectee is fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate.
- iv. The selectee shall give an undertaking by way of affidavit duly attested by the Judicial Magistrate 1st Class to the effect that they will not apply for transfer in any case where he/she have been adjusted/posted.
- v. The appointment of the candidate shall be subject to outcome of any writ petition(s), if any, pending in any court of competent jurisdiction.

The Chief Education Officer, Srinagar shall allow the candidate to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- · Permanent resident certificates
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The format appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such order shall be drawn, in any case.
