The candidate be allowed to join provisionally in absence of verification of her character/antecedents report from the CID. In case of adverse report from the CID, the order should be deemed to have been cancelled and will have no claim for salary for the period she worked and an undertaking to this effect be also obtained from her for record and reference.
