**Sub: Passing of type test/Regularization of I/c Junior Assistants who have qualified type test on Computer Key Board.**

Whereas, the Department has from time to time placed Class-IV employees as I/c Jr. Assistants in OPG and their confirmation is subject to the passing of type test with requisite speed of 25 words per minute under SRO 308 of 2008 dated 16/10/2008, readwith circular No: 32 GAD of 2011 Dated: 28/09/2011.

Whereas, the Divisional Departmental Promotion Committee meeting was held on 19/09/2018, among other agenda points, the matter regarding confirmation of I/c Junior Assistants as Junior Assistants was placed before the committee as Agenda No: 04.

Whereas, the DPC agreed to the confirmation of **41 (forty one)** I/c Junior Assistants in District Anantnag, Budgam and Kupwara, who have qualified the type test by registering more than 25 words speed per minute on computer Keyboard, conducted by the Concerned District Industrial Training Institutes, as per the result statement submitted by the concerned Chief Education Officers, subject to the obtaining of fresh vigilance clearance from GAD (Vigilance).

Whereas, **39 (thirty nine)** I/c Junior Assistants (*in whose favour vigilance clearance from GAD (Vigilance) was received*) were confirmed w.e.f. **05/02/2019** vide order No: 179-DSEK of 2019 Dated: 05/02/2019, No: 609-DSEK of 2019 Dated: 17/07/2019, No: 731-DSEK of 2019 dated: 24/09/19 and 757-DSEK of 2019 Dated: 12/10/2019.

Whereas, the Administrative Department vide letter No: EDU/I/313/2009-V Dated: 03/02/2020, has conveyed fresh vigilance clearance issued from GAD (Vig) vide O.M.No: GAD(Vig)NOC/2019-Edu-VII Dated: 25/11/2019, in favour of **01 (one)** I/c Jr. Assistant, figuring at S.No.35, in the DPC approved list.

Now, therefore, as approved by the Divisional Departmental Promotion Committee and cleared by GAD (Vigilance), sanction is hereby accorded to the confirmation as Junior Assistant/regularization of below named **01 (one)** I/C Junior Assistant whose particulars are given against his name, as Junior Assistants in the pay level 4 (25500-81100) w.e.f.05/02/2019.

- The confirmation/regularization shall be without prejudice to the final outcome of the case, if any sub-judice/impugned or pending before the Hon'ble Court or any other court and other orders, if any passed by the competent authority, which may not be immediately within the knowledge of this Directorate.
- The Chief Education Officer must ensure that there is nothing adverse against the official from the VoK/Crime/Police/CID.
- The official must necessarily be holding substantive genuine appointment and un-interrupted service. The benefit of regularization shall not be allowed in case the official is under suspension or in case the departmental proceeding may be pending against him or his work and conduct may not be satisfactory.
