Whereas, Shabir Ahmad Dar whose recommendation was initially kept withheld by J&K Service Selection Board and later released vide letter No. SSB/Secy/Sel/149/2018/1461-63 dated 06/03/2019 conveyed by Administrative Department vide letter No. Edu-I/521/2018 dated 26/04/2019 figuring at SSB Sr.No. 02 (OM category) under waitlist in District cadre Baramulla becomes eligible due to the cancellation of recommendation in respect of Lubina Gazal, and
