Sanction is hereby accorded to the temporary appointment of Mr. Muneeb Iqbal Sofal S/o Late Mohammad Iqbal Sofal deceased Library Assistant, Govt. Girls Higher Secondary School Mattan, R/o Sherpora Payeen Qasbabaghat District Anantnag as (Class-IV) in the Pay level- SL1 (14800-47100), in High School Brakpora in District Cadre Anantnag in terms of SRO-43 of 1994.

The appointee shall report to the Chief Education Officer Anantnag within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates in original to be verified subsequently:-

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Domicile Certificate
- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- v. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- vi. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- vii. All other relevant documents as are required under SRO-43/1994

The appointment of the appointee, shall further be subject to the following conditions:-

- (a) That he shall give an undertaking in the shape of an affidavit to the effect that:-
 - (i) *In case if any adverse report about his character and antecedents is received from the Inspector General of Police (CID), J&K, to whom a reference shall be made by the concerned Chief Education Officer, he shall have no right to claim his appointment as Class-IV in Education Department and his appointment, as such, shall be deemed to have been cancelled ab-initio;*
 - (ii) *If, on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Class-IV shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.*
- (b) The salary of the appointee shall not be drawn and disbursed to him, unless a satisfactory report in respect of (i) & (ii) above are received in his favour.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as per SRO-400 of 2009 dated 24-12-2009.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall cease his right to appointment which shall be cancelled ab-initio without any further notice.


