**ORDER NO. 1213 DSEK of 2016  
DATED 08/07/2016**

Consequent upon their placement as I/C Headmaster & Equivalent issued vide Order No. 923 DSEK of 2016 dated:- 30-05-2016, sanction is accorded to the posting of 12 Headmasters & Equivalent against available slots in the Schools shown against each as per annexure-A to this order in their own pay and grade for a period of 06 months or till clearance by PSC whichever be earlier. They shall be entitled for drawal of charge allowance as admissible under rules.

The officers given higher placement by virtue of Order No. 923 of 2016 shall immediately report to concerned institutions/offices for further duties as indicated against each after verification of their service particulars as shown in Order No. 923 dated:- 30-05-2016 by reference to relevant records by CEO concerned. In case any variation in respect of service particulars as indicated against each detected, the same should be brought to the notice of this Directorate by DDO immediately for further instructions. In that case, the implementation of the order be stopped.

The officials thus placed as I/C Headmasters & Equivalent shall invariably join their respective place of postings within (10) days and those who fail to take up the higher assignment within stipulated time shall be deemed to have forfeited the said assignment/placement.

To cater to deficiency of DDO's, Sanction is also accorded to the assigning additional charge of the ZEPO's as I/C Headmasters of the Headless High Schools as per annexure-B to this order with authority to function as DDO's for these Schools with immediate effect till the posts of Headmasters are filled.


