ADVERTISEMENT NOTICE

Reference:- Govt. Order No. 124 Edu of 2019 dated 08-03-2019

- Whereas, in response to the Government Order No. 78 Edu of 2019 dated 22-02-2019, an advertisement notice for hiring of Lecturers purely on academic arrangement on the basis of academic merit was published in local Dailies "Rising Kashmir" and "Aftab" on 04-03-2019 and 5-03-2019 respectively.
- Whereas, various representations were received from some aggrieved candidates who were engaged as Contractual Lecturers for the last academic session viz. 2018 and requested for conducting Screenining test on the same lines as was adopted for the academic session-2018.
- 3. Whereas, the aforesaid reprsentations were under examination and in the meanwhile, the Administrative Department vide Order No. 124 Edu of 2019 dated 08-03-2019 accorded sanction to the temporary re-hiring of interested eligible Lecturers, who have already rendered their service during the last academic year 2017-2018 purely on academic arrangement basis from 11-03-2019 subject to the following conditions:-
 - The candidate fulfills the eligibility conditions prescribed under recruitment rules for the post of Lecturers;
 - ii. The candidate shall give fresh affidavit/under recruitment rules for the post of
 Lecturer:
 - iii. The hiring shall come to an end on 30-06-2019 or filling up of the posts by way of promotion or selection of suitable candidates by way of screening being done by respective Directors/Chief Education Officers of School Education Department whoever is earlier.
- Whereas, the aforesaid decision of the Govt. also stipulated the conditions that the selection of the eligible candidates has to be made by way of screening.
- 5. Whereas, keeping in view the totality of facts and circumstances explained above, it has become necessary to withdraw the earlier advertisement notice issued on the subject and issue a fresh advertisement notice for selection of Lecturers on academic arrangement basis for the academic session-2019 by way of screening test on the same pattern as was adopted during-2018.

Now, therefore,

- a. It is hereby ordered that the advertisement notification issued under No. DSEK/Estt-1/2016 dated 02-03-2019 be treated as withdrawn:
- b. Consequent upon the above, fresh applications are invited from eligible candidates for hiring of Lecturers on academic arrangement basis for the academic session-2019. Those candidates who have already applied in pursuance of advartisement notification published on 04-03-2019 and 05-03-2019 need not to apply afresh. However, the said candidates shall have to deposit an amount of Rs. 100/= in the office of concerned Chief Education Officer, failing which their application shall be considered as rejected.

Terms & Conditions:-

1. The engagement shall be made purely on 'Academic Arrangement' at +2 level on monthly consolidated remuneration of Rs. 10500/= (Rupees Ten Thousand & Five hundered only) for plain areas and Rs. 14000/= (Fourteen Thousand only) for III/Hard Zones per month for the session-2019.

2. The candidates will be engaged initially for a period of 03 months which will be renewed subsequently strictly on need basis for another 03 months maximum upto the completion of the Academic session or till these posts are filled up by

appointment/posting of regular incumbent which ever is earlier.

3. The engagement thus made shall not have any preferential claim to the candidates for selection/absorption on regular basis. The selected candidates have to tender an affidavit/undertaking to this effect before issuing engagement orders in their favour. Applications should be supported by the self-attested photocopies of the following certificates/testimonials:-
