No. 03 of 2012 and 02 of 2013**, under item No. **281(operation of wait list)**.

Whereas; the Administrative Department vide letter No. Edu-I/15/2017, dated. 20/03/2017, has forwarded select list of six (06) Jr. Stenographers (OM=05, OSC=01), Divisional Cadre Kashmir, issued by the Service Selection Board vide No. SSB/Secy/Sel/2017/201-207, dated 06/01/2017;

Whereas; recommendation in respect of two candidates has been kept withheld by Service Selection Board for certain clarifications;

Whereas; withhold recommendation in respect of one candidate figuring in the select list at S.No.(05) was released by Service Selection Board vide No. SSB/Sel/Secy/12/17/1095-97, dated. 23/01/2017, leaving (05) five selectees to deposit the requisite original as well as self attested certificates/testimonials in this Directorate.

Whereas, this office vide Notification No. DSEK/NT/SSB/537/2017/All/758, dated. 01/05/2017, appeared in press through information department on 02/05/2017, directing the selectees to deposit the requisite original as well as self attested certificates/testimonials in this Directorate within (10) days from the date of publication of the notification in the press;

Whereas, In response to the said notification (02) candidates, (OM=01, OSC=01) have deposited their documents and their provisional appointment order were issued, vide order No. 509-DSEK of 2017, dated 01/06/2017;

Whereas; the candidates, who failed to deposit their documents in the Directorate despite given final opportunity to deposit the same within (07) days vide notification No. DSEK/NT/SSB/537/2017/All/993, dated. 14/06/2017, appeared in press on 19/06/2017, have again failed to do so;

Whereas, due to non-submission of documents/certificates by some candidates, the matter has been take-up with the Administrative Department vide this office letter No. DSEK/NT/SSB/537/2017/All/1156, dated. 10/07/2017 for authorisation of operating of wait list.;

Whereas, the Admn. Deptt. vide letter No. Edu-I/15/2017, dated 31/07/2017, has conveyed approval for operating wait list against the slots which became available due to non-depositing of documents by the selected candidates;

Whereas, this office vide notification No. DSEK/NT/SSB/537/2017/All/1385-86, dated 30/08/2017, appeared in press through Information Department on 01/09/2017, directing the two selectees under wait list to deposit their requisite original as well as self attested certificates, in this Directorate within ten (10) days from the date of publication of the notification in press;

Whereas, in response to the said Notification only 01 (one) candidate has deposited his requisite documents in this Directorate for processing of his appointment orders;

Now therefore, sanction is hereby accorded to the provisional appointment of the below named **One (01)** candidate selected as **Junior Stenographer Divisional Cadre Kashmir**, under **wait list**, in the pay band of Rs.9300-34800+ grade of Rs.4200/-, the merit position assigned by the SSB is indicated against his name:-

Consequent upon his appointment as Jr. Stenographer (**Divisional Cadre**) he is posted to the available vacancy of Jr. Stenographer in DIET Ganderbal.

The candidate is required to report to DIET Ganderbal within twenty one (**21**) days from the date of issuance of this order on his own risk and responsibility till the CID verification received from the CID/Police Department.

The appointee shall be governed under New pension Scheme as notified vide **SRO-400 2009 dated 24/12/2009**.

The appointee shall be on probation for a period of two years and subject to production following certificates (in original).

- ❖ Character and antecedents certificate from Inspector General of Police (CID)
- ❖ Qualification certificates / Technical qualification certificate.
- ❖ Permanent resident certificate
- ❖ Age and health certificate
- ❖ Discharge certificate from the Institution attending/ last attended
- ❖ Certificates from District Industries Centre/Employment Exchange to the effect that no loan under self employment scheme has been taken by the appointee
- ❖ Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.

The salary of the appointees shall not be drawn and disbursed unless;

- Satisfactory report about his character and antecedents is received from **Inspector General of Police (CID) J&K** and **category certificates** (if any) from the issuing authority.
- The appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his character and antecedents is received from the concerned **Inspector General of Police (CID) J&K**, the appointee shall have no right to claim his appointment as **Jr. Stenographer** and appointment as such shall be deemed to have been cancelled ab-initio.
- The appointee shall give an undertaking duly attested by the Judicial Magistrate 1st Class that he will not apply for transfer from **Kashmir Division** in any case, and in case, at a stage it emerges that the certificates/ any relevant document furnished/ produced by the selectee is fake/fictitious, the appointment order shall be cancelled ab-initio and criminal proceeding shall be initiated against the candidate.

After receiving verification report viz; date of birth, qualification, marks, category and other Certificates from the issuing authorities through concerned CEO duly counter-signed, the appointment order will be issued accordingly and no salary will be drawn in favour of the candidate till formal appointment order is issued from this Directorate.

The inter-se seniority of the appointee shall be in the order in which his name appears in the select wait list furnished by the J&K Services Selection Board.

The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in any court of competent jurisdiction and any order which may not be presently within the knowledge of this Directorate.
