Subject:- Grant of In-Situ Promotion under Higher Standard Pay scale Scheme.

The In-situ Promotion to the higher standard pay scale in favour of said official is granted/ released subject to the fulfilment of the following conditions:-

- That the Chief Education Officer / Drawing and disbursing officer concerned will verify the particulars of official with reference to his original services records before allowing (In-Situ) promotion benefit and he/she shall be personally responsible for correctness of the particulars of the employee working under him/her. In case any variation is noticed in the particulars of official, the benefit of the in-situ promotion shall not be released and the case referred to this Directorate for further orders/ clarification.
- The CEO/DDO concerned shall not implement the order in case there is any case /enquiry pending against the official in any investigation agency or department.
- That the incumbent has completed required spell of 09/18/27 years as the case may be satisfactorily and without any interruption as defined in rule 4(K) of SRO-14, Dated.15.01.1996.
- That the incumbent was not under suspension or contemplated in any charge or charge sheeted under classification Control and Appeal Rules 1956 or any other rules and her work and behavior has remained satisfactory.
- That the present promotion In-Situ shall not change/ affect the existing designation/ seniority /duties of the employee.
- That the benefit of the promotion In-Situ shall not be applicable, if the official has earlier foregone regular / functional promotion or will forego her functional promotion in future.
- That the work and behavior of the official has remained satisfactory during the preceding 03 (three) years.
- That before implementing the order, the concerned CEO shall ensure that the employee is holding substantive appointment and her appointment is genuine, before endorsing this order to sub- office for implementation.
- That no time bound promotion has been granted by the DDO/CEO at his own level in favour of the incumbent.
- Consequent upon grant of HSP's it shall be ensured that the pay has been /is regulated strictly in accordance to the provisions laid down in SRO-14 and SRO-93 dated.15.01.1996 dated.15-04-2009 and Govt. Order No.07-F and Govt order No.08-F dated.18/01/2011 read with SRO-42 dated.02/02/2011 and Govt Order No.238-F of 2011 dated.30.09.2011, and SRO-193 of 2018 dated.24.04.2018.
- It shall be personal responsibility of the concerned Chief Education Officers to verify the particulars of the employee and observance of all Codal formalities and conditions mentioned herein above and the DDO's concerned shall give effect/ draw the arrears on account of time bound promotion after getting the entries to this effect recorded in the service book, duly countersigned by the Concerned Chief Education Officer.
- That the appointment order of official has been issued by the Competent authority.
- That there are no criminal case/ proceedings pending against the above official before any investigating agency viz: (VOK/ crime branch) or court of law and the genuineness of appointment has been ascertained/ established in respect of the employee.
- The DDO must ensure that the official is holding a genuine appointment.
- The In-situ promotion of the official is released, subject to the producing of affidavit by the officials duly attested by judicial Magistrate to the effect that in the event to her confirmation as Lecturer, recovery of excess pay (if any) shall be made in lump sum.
