Whereas, Ms. Pammy Kumari D/o Sh. Sham Lal Pardesi R/o Kharbrari Tehsil Kulgam was appointed as Class-IV (Lab. Bearer) under SRO-43 of 1994, vide order No: 730-DSEK of 2002, dated 08/03/2002 in District Cadre Anantnag.

Whereas, District Anantnag was bifurcated and District Kulgam was carved out from it in the year 2007-08 and the Class-IV as per her residence came within the Administrative jurisdiction of District Kulgam as reported by the Chief Education Officer Kulgam, vide communication No: CEO/K/Estt/3609/18 dated: 28/06/2018.

Whereas, 24 (twenty four) Class-IV employees having appointment upto 19/01/2005, were placed as I/c Lib. Assistants, I/c Lab. Assistants and I/c Junior Assistants vide order No. 1671 DSEK of 2015 dated 02/06/15, on general seniority basis in District Cadre Kulgam, in which Ms. Pammy Kumari Class-IV was not considered due to non-availability of her service bio-data.

Now, as approved by the Divisional Departmental Promotion Committee, sanction is hereby accorded to the promotion of Ms. Pammy Kumari Class-IV (Lab. Bearer) of District Kulgam, whose particulars are given below, as Laboratory Assistant in the pay band of Rs.5200-20200 with grade pay of Rs.1900/-(Pre-Revised) w.e.f. 02/06/2015, on notional basis and with monetary benefit from the date she actually joins the higher post in District Kulgam.

The promotion of Class-IV to the post of Laboratory Assistant is subject to the fulfillment of following explicit conditions:-

1. If the Class-IV employee as named above in the promotion order, is on subsequent verification, found not eligible for such promotion, this order will not confer any right on her and her promotion on the higher post (made hereby) shall be rescinded in that case. It will be personal responsibility of the Chief Education officer/Drawing and Disbursing Officer concerned to verify particulars of the

promotee with reference to her original service records and ensure that the date of Ist appointment as Class-IV as well as other particulars recorded against her (here in above in this order) are correct. Variation if any found should be brought to the notice of this Directorate for further orders. In that case the Class-IV shall not be relieved for her promotion on the higher post.

2. The promotee must necessarily be holding substantive genuine appointment and un-interrupted service. The benefit of promotion shall not be allowed in case the promotee is under suspension or in case the departmental proceedings may be

pending against her or her work and conduct may not be satisfactory.

3. The promotion shall be without pre-judice to the outcome of the case, if any sub-judice/impugned or pending before the Hon'ble High Court or any other court and other orders, if any passed by the competent authority, which may not be immediately within the knowledge of this Directorate.

4. The Chief Education officer must ensure that there is nothing adverse against the

promotee from VOK/Crime/Police/CID.

5. The promotee is required to report to the concerned CEO alongwith service book and all other allied documents/papers within 21 days from the date of issuance of this order for seeking further adjustment in District Kulgam on the higher post, after getting herself properly relieved by the concerned DDO/Controlling Officer and countersigned by the Joint Director In-Charge Migrant Cell Jammu, failing which it shall be construed that she is not willing to avail the benefit of this promotion and her promotion as such, shall be deemed to have been cancelled ab-initio without issuing further orders in this behalf.

6. This order shall have no effect on the assignment related to examination or election (if

any) given to the incumbent(s).
