Sanction is hereby accorded to the temporary appointment of Mr. Basit Wali S/o Wali Mohammad Lone (deceased Class-IV (Peon-cum- Chowkidar) BHS Warnow Lolab R/o Warnow District Kupwara as Class-IV (Peon) in the Pay level- SL1 (14800-47100), in BHSS Warnow Lolab in District Cadre Kupwara in terms of SRO-43 of 1994.

The appointee shall report to the Chief Education Officer, Kupwara within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates in original to be verified subsequently:-

1. Academic Qualification Certificate.
2. Date of Birth Certificate.
3. Domicile Certificate
4. Health Certificate from the concerned Chief Medical Officer of the District.
5. Dependent Certificate issued by the Assistant Commissioner, Revenue.
6. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
7. All other relevant documents as are required under SRO-43/1994

The appointment of the appointee shall further be subject to the following conditions:-

- (a) That he shall give an undertaking in the shape of an affidavit duly sworn in before Judicial Magistrate to the effect that:-
  - (i) *If, on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Class-IV shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.*
- (b) The salary of the appointee shall not be drawn and disbursed to him, unless a satisfactory report in respect of (i) above are received in his favour.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as per SRO-400 of 2009 dated 24-12-2009.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall cease his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
