Whereas; the Administrative Department vide letter No. Edu-I/136/2014, dated. 09/07/2014 and No. Edu-I/137/2014, dated. 09/07/2014, has forwarded select list of **Lab. Assistants** of District Anantnag and Kupwara, issued by the Service Selection Board vide No. SSB/Sel/Secy/014/4226-32, dated. 29/05/2014, and No. even dated. 29/05/2014;

Whereas, this office vide Notification No. DSEK/NT/SSB/LA/488/2014/Ang/216-217, dated. 24/10/2014, and No. DSEK/NT/SSB/LA/489/2014/Kup/214-215, dated. 24/10/2014, appeared in press through information, directing the selectees to deposit their requisite original as well as self attested certificates/testimonials in this Directorate within **(10)** days from the date of publication of the notification in the press;

Whereas, in response to the said notification the selectees who have deposited documents, their appointment orders were issued accordingly;

Whereas, due to non-submission of documents/certificates by some candidates, the matter was been take-up with the Administrative Department vide this office letter No. DSEK/NT/SSRB/488/2014/311-N/Ang-Kup/2553, dated. 29/12/2016 for authorisation of operating of wait list, wherever applicable;

Whereas, the Admn. Deptt. vide Govt. Order No. 590-Edu of 2017, dated. 30/08/2017 issued under communication No. Edu-I/287/2014, dated 30/08/2017, has conveyed approval for operation of waiting list beyond one year validity period on the rationale of procedural delay, in relaxation of sub rule (7) of Rule 14 of the J&K Civil Services Decentralization and Recruitment Rule, 2010;

Whereas, this office vide Notification No. DSEK/NT/SSB-LA/488/2014/Ang/311-N/1497-98, dated. 14/09/2017, appeared in press through information department on 21/09/2017, directing the selectees to deposit their requisite original as well as self attested certificates/testimonials in this Directorate within **(10)** days from the date of publication of the notification in the press;

Whereas, in response to the said Notification, only 02 (two) selectees of District Kupwara (**SC=01, ST=01**), have deposited their requisite documents for processing of their appointment orders;

Whereas, Tehsildar, Tangdhar Karnah, vide his letter No. 289/BQ, dated. 08/08/2014, has issued clarification of Caste certificate in favour of Imtiaz Ahmad S/o Mohd Yaqoob R/O Hundwal (Nachyan) Tehsil Karnah District Kupwara.

Now, therefore, Sanction is hereby accorded to the provisional appointment of below named two selectees, as Laboratory Assistant in District Cadre **Kupwara**, in the pay band of Rs.5200-20200+ grade pay Rs.1900/. The candidates are required to report to the Chief Education Office **Kupwara** within (21) days from the date of issuance of this Order, for further posting against the available vacancy in needy institution, on their own risk and responsibility till the verification/authentication of all relevant documents/Certificate are received from the concerned agencies.

The appointee shall be governed under New pension Scheme as notified vide **SRO-400 of 2009, dated 24.12.2009.**

The appointee shall be on probation for a period of two years and subject to production of following certificates (in original) before the Chief Education Officer, **Kupwara** who shall to get these certificates verified/authenticated from the concerned issuing authorities

- i. Character and antecedents certificate from Additional Director General of Police (CID).
- ii. Academic /Qualification certificates.
- iii. Permanent resident certificate
- iv. Age and health certificate
- v. Discharge certificate from the Institution attending/last attended
- vi. Certificates from District Industries Centre/Employment Exchange to the effect that no loan under-self employment scheme has been taken by the appointee.
- vii. Category certificates (in case of reserved categories) under SRO.294 of 21/10/2005.
- viii. Total Marks obtained and percentage of the selectee in consonance with the merit list authenticated from the original certificates.

**The salary of the appointees shall not be drawn and disbursed unless;**

- Satisfactory report about his/her character and antecedents is received from **Inspector General of Police (CID) J&K** and genuineness/verification report for qualification/Technical Certificate/ Marks Certificates and category certificates (if any) from the issuing authority.
- Appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his/her character and antecedents is received from the concerned **Inspector General of Police (CID) J&K**, the appointee shall have no right to claim his/her appointment as **Lab. Assistant** and appointment as such shall be deemed to have been cancelled ab-initio.
- The **Chief Education Officer, Kupwara** will adjust the candidates against clear vacancy in needy institutions without involving transfers.
- If on verification the certificates produced by the appointees are proved fake or forged, the appointment shall be cancelled/abinitio.
- They shall give an undertaking duly attested by the Judicial Magistrate 1st Class that they will not apply for transfer from District **Kupwara** in any case.

After receiving verification report viz; date of birth, qualification, marks, category and other Certificates from the issuing authority through concerned Chief Education Officer duly counter-signed, formal appointment order will be issued accordingly and no salary will be drawn in favour of the candidate till formal appointment order is issued from this Directorate.

The inter-seniority of the appointee shall be in the order in which his name appear in the select list furnished by the J&K Services Selection Board.

This order is issued without prejudice to any writ petition(s)/suit, if any, pending/sub-judice before the Hon'ble High Court or any other court of law or any order which may not be presently within the knowledge of this Directorate.
