Sub;- Grant of Promotion IN-SITU of Higher Standard pay scale.

ORDER No. 150 (Acctt)-DSEK of 2019

Whereas, vide different orders issued from time to time, the under graduate teachers who passed their graduation were granted In-Situ promotion after putting 09 year's, service as teacher from the date of passing Graduation;

Whereas, the matter was taken up with Administrative Department for clarification regarding entitlement of In-Situ promotion in such cases vide this office letter No.DSEK/Acctts/TBP/pay/14510 Dated.03.01.2018;

Whereas, the Administrative Department vide letter No.Edu/TBP/Pay/38/2018/213 dated.23.02.2018, clarified that the teachers appointed on the basis of academic qualification of (10+2) under graduate level are entitled for their In-Situ promotion from the date of their 1st appointment in light of clarification issued by the Finance Department vide O.M No. A/29 (90)-1034 of 20.10.1996 and O.M No.A/29/96-7016 of 05.08.1997, in terms of SRO-14 dated.15.01.1996 of J&K Civil Service (Higher Pay scale Scheme) Rule 1996;

Whereas, this office received some cases of teachers from the concerned CEO's for review in light of clarification received from the Administrative Department;

Whereas, vide this office Circular No.DSEK/Acctt/TBP/Grad/43 Dated.27.06.2018, the CEO's were requested to furnish cases of all such teachers (whose In-Situ promotion cases were considered taking into account date of passing graduation, instead of initial appointment as under graduate) in consolidated manner;

Now, therefore, in continuation to this office order No.4715 (Acctts)-DSEK of 2018 Dated.12.09.2018 and in face of clarification received from Administrative Department/ recommendations of concerned CEO's, the following **03 (three)** official shall be allowed In-Situ promotion benefits to the HSPS Rs.9300-34800+GP-4200 from the date indicated against each, on the same terms and conditions as laid down in their respective In-Situ promotion orders.
