Whereas, vide Govt order No. No. 213-HE of 1989, dated. 23/06/1989, the mutual transfer in between Shri Baharat Ji. Orderly Govt. High School Lalpora Tangmarg School Education Department and Sh. Gh Mohd Reshi Orderly Govt. College of Women Baramulla District Baramulla Higher Education Department, was made with the condition that both the employees shall retain their lien in the respective parent department.

Whereas, the Directorate of Colleges, (Higher Education Department) Civil Secretariat, vide letter No. EC/Coll.NOK/PF-86, dated. 17/03/2011, had requested to intimate whether Sh. Gh Mohd Reshi Orderly of Higher Education Department has been absorbed in the School Education Department. So that the request of Sh. Bharat Ji, orderly of School Education Department, is considered for his absorption in the Higher Education Department.

Whereas, The Chief Education Officer Baramulla vide letter No. Estt/G/10545 dated. 07/08/2012, has intimated that Sh. Gh Mohd Reshi Orderly ZEO's Office Kunzar (Ex. Orderly Govt. College for women Baramulla) Higher Education Department, has chosen to remain in School Education Department for all consequential benefits.

Whereas, the lien of Sh Bahrat Ji Ex. Orderly District Baramulla, School Education department, presently working in Higher Education Department, has not been terminated as yet and Sh. Gh Mohd Reshi Ex. Orderly Higher Education Department presently working School Education Department District Baramulla, is continuing as orderly in ZEO's Office Kunzar and has received TBP and other service benefits in School Education Department.

Whereas, the Higher Education Department Civil Secretariat, Srinagar vide letter No. HE/Cool/PF-LA/NGK/06/2016, dated. 21/09/2016, has requested to terminate the lien of Sh. Baharat Jee Bhat, from School Education Department, under intimation, enabling permanent absorption of Shri. Baharat Ji Bhat in Higher Education Department.

Whereas, since both the officials have served out of their parent department for more than 26 years, and thus retention of their lien in parent department does not serve any purpose.

Now, therefore, in view of the above, the lien of Shri Baharat Ji Bhat Ex. Orderly of this department (presently working in Higher Education Department) is hereby terminated with immediate effect, form School Education Department to facilitate his permanent absorption in Higher Education Department.
