**However, before implementing the order the revised date of regularization shall be recorded on the 1<sup>st</sup> page of service book of the RRT Teacher by the DDO concerned, which shall be countersigned by the CEO concerned and same copy furnished to this office of record and reference, and the promotion In-situ to the higher standard pay scale in favour of said RRT Teacher is granted/ released subject to the fulfilment of the following conditions.**

- That the Chief Education Officer / Drawing and disbursing officer concerned will verify the particulars of the official with reference to his original services records before allowing (In-Situ) promotion benefit and he shall be personally responsible for correctness of the particulars of the employee working under him. In case any variation is noticed in the particulars of official, the benefit of the in-situ promotion shall not be released and the case referred to this Directorate for further orders/ clarification.
- The CEO/DDO concerned shall not implement the order in case there is any case /enquiry pending against the official in any investigation agency or department.
- That the incumbent has completed required spell of 09/18/27 years as the case may be satisfactorily and without any interruption as defined in rules 4(K) of SRO-14, Dated,15.01.1996.
- That the incumbent was not under suspension or contemplated in any charge or charge sheeted under classification Control and Appeal Rules 1956 or any other rules and his work and behaviour has remained satisfactory.
- That the present promotion In-Situ shall not change/ affect the existing designation/ seniority/ duties of the employees.
- That the benefit of the promotion in-Situ shall not be applicable, if the official has earlier foregone regular / functional promotion or will forego his functional promotion in future.
- That the work and behaviour of the official has remained satisfactory during the preceding 03 (three) years.
- That before implementing the order, the concerned CEO shall ensure that the employees are holding substantive appointment and his appointment is genuine, before endorsing this order to sub- office for implementation.
- That no time bound promotion has been accorded by the DDO/CEO at his own level in favour of any employee.
- In case, if it has been found that the time bound promotion has been sanctioned in favour un- regularized Migrant substantive/ contractual by virtue of this order, the same should not be given effect.
- Consequent upon on grant of HSP's has granted shall be regulated strictly in accordance to the provisions laid sown in SRO 14 and SRO-94 dated.15-04-2009 and Govt. Order No.07-F and Govt order No.08-F dated.18/01/2011 read with SRO-42 dated.02/02/2011 and Govt Order No.238-F of 2011 dated.30.09.2011 in addition rules 2.43 of F.C Vol I be also implemented while Implementation of the (In-Situ) promotion order.
- It shall be personal responsibility of the concerned Chief Education Officers to verify the particulars of the employee and observance of all Codal formalities and conditions mentioned herein above and the DDO's concerned shall give effect/ draw the arrears on account of time bound promotion after getting the entries to this effect recorded in the service book, duly countersigned by the Concerned Chief Education Officer.


