In case the appointee fails to join and produce the certificates within 21 days from the date of issue of this order, the order will cease to operate without any notice to the appointee. The candidate be allowed to join provisionally in absence of verification of his character/antecedents from CID. However, his pay shall not be drawn and paid till the verification of his character / antecedents is received from the CID. In case of adverse report from the CID, the order should be deemed to have been cancelled & will have no claim for salary for the period he worked, and an undertaking to this effect be also obtained from him for record and reference.
