Now, therefore, as approved by the Divisional Departmental Promotion Committee and cleared by GAD (Vigilance) vide O.M. No: GAD(Vig)14-NOC/2018-Edu-III Dated: 03/01/2019 conveyed by Admn. Department vide letter No: EDU-I/313/2009-IV Dated 11/01/2019, sanction is accorded to the regularization/promotion of Mr. Bashir Ahmad Wani I/C Junior Assistant as Junior Assistant in the pay level 4 (25500-81100) with immediate effect.

- The regularization shall be without prejudice to the final outcome of the case, if any sub-judice/impugned or pending before the Hon'ble Court or any other court and other orders, if any passed by the competent authority, which may not be immediately within the knowledge of this Directorate.

The benefit of regularization shall not be allowed in case the official is under suspension or in case of the departmental proceeding may be pending against him or his work and conduct may not be satisfactory.
