Sub: Acquiring of higher qualification by Mr. Nabaz Ahmad Sheikh RRT Teacher UPS Hafrada Kupwara and settlement of period thereof.

Order No: 165 DSEK of 2022
Dated: 15 /02/2022

Whereas, Mr. Nabaz Ahmed Sheikh was engaged as ReT Teacher in UPS Hafrada District Kupwara in the Department on 11/10/2003 as (Science Graduate) and regularized after completion of 05 years service on 11/10/2008; and

Whereas, the teacher got regular admission for pursuing Post-graduation in Environmental Science through Doon (PG) College of Agriculture Science and Technology, Uttrakhand University Dehradun in the year 2012 and completed the course on 27/12/2014 ; and

Whereas, the teacher on one hand was on the rolls of the said university during the period in question and on the other he has regularly drawn the salary from his substantive post; and

Whereas, after the issue was brought in to the notice of this Directorate, a committee of following officials/officers was constituted by this office to enquire how the teacher managed to acquire post-graduation degree and drawn the salary regularly during the period he was on the rolls of the University vide Order No. 797-DSEK of 2018 dated 09/06/2018:-

1. Joint Director, North.
2. Chief Accounts Officer, DSEK
3. Sectional Officer, Teaching

Whereas, the committee furnished its findings and recommended that *"the RRT has drawn Rs. 531540/- as salary as per due-drawn statement of ZEO Villigam furnished by Dy. Chief Education Officer, Handwara. During the period the RRT was on rolls of the Doon PG College of Uttrakhand Technical University Dehradun for completion of PG and on the other side was also receiving his salary when he was not performing his duties. Besides, the RRT has not obtained proper permission/sanction of leave, from the competent authority which was pre-requisite as per the standing norms. The Committee is of the opinion, that the ZEO who has drawn the salary in favour of the RRT for the period in question shall be held responsible for such irregularity and action as warranted under rules may be initiated against him, besides the salary drawn by the RRT during the period shall be recovered from the RRT and remitted into treasury immediately and the period w.e.f. October 2012 to 27-12-2014 spent on completion of PG is suggested to be treated as Dies-Non also it must be ensured that the degree so obtained will not be considered by the Department for any future promotion or monetary benefit."*; and

Whereas, the Chief Education Officer Kupwara was requested to communicate the name, present designation and present posting of Drawing and Disbursing Officer/Clerk/Dealing Assistant who were working in Zonal Education Officer's office Villigam Kupwara during which period the teacher has drawn the salary in the year 2012-14 vide this office No. DSEK/Estt/III/B-Trs/Misc/18/2017/K.up/1374 dated 12/08/2021; and

Whereas, the Chief Education Officer Kupwara vide his communication No. CEOKUP/Trs/study-Pe/9/2021/6793-94 dated 11/09/2021 communicated the name of two (02) DDO's and two (02) Senior Assistants who were posted in Zonal Education Officer's office Villigam Kupwara in the year 2012-14, but two (02) DDO's have already retired on superannuation; and

Whereas, upon examination of the issue it was observed that the recommendation made by the Enquiry Committee need to be upheld;

Now, therefore sanction is hereby accorded to the:-


- (i) recovery of an amount of Rs.5,31,540/- (Rupees Five Lakh Thirty-one Thousand Five Hundred Forty only) from Mr. Nabaz Ahmed Sheikh which shall be remitted into concerned Treasury under relevant Account Head against the proper challan. The entry to this effect may also be recorded in the service records of the official.
- (ii) the period spent by the teacher w.e.f. October 2012 to 27-12-2014 shall be treated as "Dies-non".
- (iii) placing of following 02 officials under suspension who were working in Zonal Education officer's office Villigam Kupwara during the period the teacher drawn the un-due salary (when the teacher was on the rolls of university for acquiring post-graduation degree) with immediate effect.
