- i. Academic Qualification Certificate.
- ii. Age and Health Certificate.
- iii. Permanent Resident Certificate.
- iv. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- v. All other relevant documents as are required under SRO-43/1994.
- vi. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.

The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of his character and antecedents and other required certificates is received from the Inspector General of Police CID/ concerned issuing authority, to whom a references shall be made by Chief Education Officer Budgam separately.

The appointee shall furnish an undertaking duly attested by 1<sup>st</sup> class Magistrate to the effect that in case of adverse report from CID and other concerned agencies and other certificates from issuing authorities he shall not claim any salary for the period he has worked.
