- 1. That the Chief Education Officer / Drawing and disbursing officer concerned will verify the particulars of the official with reference to his original services records before allowing (In-Situ) promotion benefit and she shall be personally responsible for correctness of the particulars of the employee working under him. - 2. That the incumbent has completed required spell of 09/18/27 years as the case may be satisfactorily and without any interruption as defined in rules 4(K) of SRO-14, Dated.15.01.1996.
- That the incumbent was not under suspension or contemplated in any charge or charge sheeted under classification Control and Appeal Rules 1956 or any other rules and his work and behaviour has remained satisfactory.
- 1. That the present promotion In-Situ shall not change/ affect the existing designation/ seniority/ duties of the employee.
- 5. That the benefit of the promotion in-Situ shall not be applicable, if the official has earlier foregone regular / functional promotion or will forego his functional promotion in future.
