Whereas, in compliance to the instructions of the Administrative Department issued vide letter No. Edu-I/521/2018 dated 14/03/2019 regarding the cancellation of appointment of non-joining candidates and operation of waitlist thereof, the appointment order issued vide No. 1166-DESK of 2018 dated 10/09/2018, and order No. 458-DSEK of 2019 dated 04/05/2019 in District cadre Budgam, in respect of three non-joining Library Assistants (OM=01, RBA=01, SC=01), was cancelled vide this office order No. 562-DSEK of 2019 dated 03/07/2019; and

Whereas, only 02 (two) selectees (OM=01, RBA=01) in District cadre Budgam were next in order of merit under waitlist as Library Assistants and as desired by the Administrative Department vide above referred letter the appointment order was issued in their favour vide order No. 634-DSEK of 2019 dated 27/07/2019, published in daily newspaper Tameel Irshaad on 29/07/2019, directing the appointees to report the concerned Chief Education Office within 21 days from the date of issuance of the order, for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant Documents /Certificate is received from the concerned issuing agencies; and

Whereas, pursuant to the issuance of appointment order No. 634-DSEK of 2019 dated 27/07/2019, one candidate namely Mudasir Ali Raina, Library Assistant (RBA, wait) has failed to join in the Chief Education Office Budgam within the stipulated period of 21 days, as reported by the Chief Education Officer, Budgam, vide letter No. CEOB/NT/2019/16293 dated 17/10/2019; and

Now, therefore, in view of the facts indicated above, the appointment as Library Assistant vide order No. 634-DSEK of 2019, dated 27/07/2019, in respect of Mudasir Ali Raina S/o Ali Mohd Raina, R/o Budgam, figuring at SSB, Sr. No. 01, RBA category under waitlist against Notification No. 02 of 2017 item No. 084, is hereby cancelled ab-initio.
