- That the Drawing & Disbursing Officer concerned will verify the particulars of official with reference to his/her
 original service records before allowing (IN-SITU) promotion benefit and he shall be personally responsible for
 correctness of the particulars of the official. In case any variation is noticed in the particulars of any such
 official, the benefit of in-situ promotion shall not be released and such cases shall be referred for further
 orders / clarification;
- 2. That the incumbent has completed required spell of 09/18/27 years as the case may be satisfactorily and without any interruption as defined in Rule 4(k) of SRO-14 dated.15.01.1996, and his/her service verification has been duly recorded in the service book.
- That the incumbents was/is not under suspension or contemplated in any charge or charge- sheet under Classification Control and Appeal Rules 1956 or any other rules and his/her work and behaviour have remained satisfactory;
- That the present promotion In-Situ shall not change / affect the existing designation / seniority/ duties of the employee;
- 5. That the benefit of the In-Situ Promotion shall not be applicable, if the official who has earlier foregone regular/functional promotion or will forego their functional promotion in future;
- 6. That before implement the order, the concerned DDO shall ensure that the employee is holding genuine appointment on substantive basis in school Education Department;
- 7. That no time bound promotion has been accorded by the DDO/CEO at his own in favour of any official and none of the official has received this benefit so far;
