**Sub:-** Select list of the candidates under SRO 202 for the post of "General Teacher" School Education Department District Cadre Anantnag, Bandipora, Budgam Baramulla, Ganderbal, Kulgam, Shopian, Pulwama and Srinagar, and issuance of provisional appointment order thereof.

**Ref:-** Administrative Department's communication No. Edu-I/86/2019 dated:03/03/2020.

**ORDER NO. 240 DSEK OF 2020**  
**DATED: 28 / 04 / 2020**

Whereas, the Administrative Department vide communication No. Edu-I/86/2019 dated 09/05/2019 forwarded list of candidates who were selected as "General Teacher" in various District Cadres of Kashmir Division pursuant to their selection made by the J&K Services Selection Board in terms of SRO-202 of 2015;

Whereas, among others the selection in respect of **Forty-One** candidates (27 from selection Zone and 14 from Waiting list) was kept withheld by the JKSSB for want of certain clarification, which has now been released vide various its communications conveyed by the Administrative Department vide letter No. Edu-I/86/2019 dated:03/03/2020 and has advised to issue appointment orders in favour of the candidates falling in the selection zone in terms of SRO-202 of 2015, dated 30.06.2015;

Whereas, out of these 27 candidates, provisional appointment order can be considered in respect of **Twenty-four** candidates only, leaving **Three** candidates against whom there is some legal impediment;

Whereas, after perusal of the relevant records, **Seven** candidates from the waiting list also make their place in the selection zone and can be considered for appointment against the slots which were accrued due to non-joining of the equal number of candidates in the respective categories/Districts;

Now, therefore, on the recommendations of JK SSB and instructions of Administrative Department, sanction is hereby accorded to the Provisional appointment of **Thirty-One (31)** candidates as "General Teacher" in District Cadre Anantnag, Bandipora, Budgam Baramulla, Ganderbal, Kulgam, Shopian, Pulwama and Srinagar as per annexure to this order in the Pay Level 5 (Rs. 29200/-) strictly in terms of SRO-202 of 2015 dated 30.06.2015 against the available slots, subject to the final outcome of the cases, if any, pending before any Hon'ble Court.

The appointment of these candidates as "General Teacher" is subject to the following conditions:-

- I. The appointees shall be on probation for a period of five years.
- II. The appointees shall be governed under New Pension Scheme as per SRO 400 of 2009 dated 24.12.2009.
- III. In case, at any stage it emerges that the certificates/any relevant document furnished/produced by the selectee is/are fake/fictitious, the appointment order shall be cancelled ab-initio and criminal proceedings shall be initiated against the candidate and to this effect the provisional appointee shall give an undertaking by way of affidavit duly attested by the 1<sup>st</sup> Class Judicial Magistrate;
- IV. The appointees shall give an undertaking by way of affidavit duly attested by the 1<sup>st</sup> Class Judicial Magistrate to the effect that they will not apply for transfer in any case where he/she have been adjusted/posted.
- V. The appointees shall give an undertaking in shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled ab-initio and he/she shall have no claim of his/her appointment.
- VI. The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in any court of competent jurisdiction.  
The appointees shall report to the concerned Chief Education Officers within a period of **21 days** from the date of issuance of this appointment order for seeking further posting orders on their own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities. In case of failure to join within stipulated time period, the appointment shall be deemed to have been **cancelled ab-initio without any further notice.**

The candidates who fail to join within a period of 21 (Twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice in light of the circular instructions issued by GAD vide No. 08-JK(GAD) of 2019 dated: 04/12/2019.

The Chief Education Officer, concerned shall allow the candidates to join on the posts after observing all the conditions of appointment order as reflected at Para 07 and after verifying the following certificates (in original):

- Character and antecedents certificate from Additional Director General of Police (CID)
- Qualification certificate viz Degree/Marks
- Permanent resident certificate
- Physical fitness certificate
- Date of birth certificate
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-Self Employment Scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority in order to ensure that the qualifications as reflected in the selection list is according to the genuineness marks card /qualification certificate.

The formal appointment order of the candidates shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary shall be drawn till issuance of confirmation order.


