Sub: Un-authorized absence case of Mtr. Akhter Noor, Teacher MP ML Higher Secondary School, Srinagar and removal of service thereof.

Order No: 230 DSEK of 2022

Whereas, Mtr. Akhter Noor, Teacher MP ML Higher Secondary School, Srinagar remained un-authorizedly absent from her legitimate duties w.e.f 20/02/2007 and left the station and proceeded outside the country without obtaining prior permission/sanction of leave from the competent authority; and

Whereas, the teacher was provided opportunities by the Drawing and Disbursing Officer concerned to resume her duties, which she failed; and

Whereas, the absconding teacher was again provided an opportunity by this office on 29/04/2021 followed by a joint show cause notice on 06/07/2021 wherein she was asked to present herself before this Directorate along with statement of defense within 07 days failing which action as warranted under rules shall be initiated against her without serving any further notice; and

Whereas, neither the teacher presented herself before this Directorate nor responded to these notices, indicating thereby that she is not interested to work in the Department; and

Whereas, in terms of circular instructions issued by the Finance Department under No. A/46(2017)-I-862 dated: 21/02/2019, "*When a State Govt. employee who intends to visit foreign country on private affairs during the period of leave prior permission of the competent authority to leave the station is required*"; and

Whereas, the issue was placed before the Designated Committee in its meeting held on 11/12/2021 and after examining the case the committee took the following decision:

***"To process for termination of services under Article-113 of J&K CSR, 1956"***

Whereas, remaining un-authorizedly/continuously absent from duties for more than five years attracts action as warranted in terms of article 113 of J&K Civil Services Rules (Volume I) of 1956, which reads as under:-

**Article 113**

***"After five years of continuous absence on leave an officer is considered to be out of state employee."***

Now, therefore, pursuant to the decision of the designated committee, Mtr. Akhter Noor, Teacher MP ML Higher Secondary School, Srinagar is hereby removed from Government service in terms of Article 113 of J&K Civil Services Rules (Volume I) of 1956 and rule 30(vii) of J&KCCA rules 1956.


