That the Rehbar-e-Taleem/s contribution in universal enrolment and retention of children has been

That the CEO/DDO concerned shall ensure that the maternity leave, if any; availed by the female ReT during 5- years honorarium service, which has not been reported/reflected earlier is entered in the service book of such ReT(s) whose regularization has been considered;

That the CEO/DDO concerned are personally responsible to verify following original testimonials and ensure that the ReT fulfils all the conditions as laid down in the above quoted Govt. Orders before giving effect to this order :-

- 1- Whereas, Primary School Bhat Mohalla has been upgraded to the level of Middle School and two posts of Teachers under SSA were sanctioned to the said school;
- **2-** Whereas the applications were invited from the eligible candidates through print media on 4.4.2010 on revenue village basis
- 3- Whereas a panel of eligible candidates was framed by VLC concerned headed by ZEO in order of merit and furnished to the selection committee as per G.O NO;597 Edu of 2003 dated:2.6.2003;
- **4-** Whereas 04 candidates applied for the said post and Mr.Syed Akhter Ali figuring at S.NO:2 of the master panel was engaged as ReT against the **Science slot**;
- 5- Whereas one candidate namely **Mr.Mohamad Altaf Dar** figuring at S.NO:01 of the master panel challenged the selection of Mr.Syed Akhtar Ali before the Hon'ble High court by way of writ petition bearing SWP NO:1247/2012 titled Mohd Altaf Dar V/State and others;
- **6-** Whereas Hon'ble court directed the Revenue Department to constitute an inquiry to ascertain whether Bhat Mohalla is separate habitation or part of Gunchipora
- **7-** Whereas the enquiry officer reported that Bhat Mohallah is not a separate habitation, but Gunchipora constitutes a separate habitation and Bhat Mohalla is a part of habitation Gunchipora;
- 8- Whereas the Hon'ble High court vide order dated 17.11.2016 in SWP NO: 1779/2016 while disposing of the writ petition directed the respondent:02(DSEK) to take decision on the report of DC Bandipora after hearing both the parties;
- 9- Whereas the petitioner also filed a contempt petition bearing NO:323/2017 and respondent NO:02 was directed by the Hon'ble High court to consider the engagement of the petitioner in accordance with the relevant norms (unless proven otherwise by the petitioner alongwith the supporting documentary proof and the compliance report was accordingly filed in contempt petition by the DSEK.
- Whereas the Hon'ble High court directed respondent NO: 02 for filing of fresh compliance report. The same was filed in the instant contempt petition came to be disposed of by the Hon'ble court vide order dated:14.8.2018, the operative portion of the same is reproduced as under:
  - "....since consideration has been accorded to the claim of the petitioner by the respondents and the case of the petitioner has been found to be meritless, therefore, the contempt proceedings are closed. However, the petitioner shall be at liberty to work out the remedy, whatever may be available to him..."
- 11- Whereas, the file of Mr. Syed Akhtar Ali ReT was finally submitted to this directorate by the Chief Education Officer Bandipora for processing the case of the petitioner for his regularization after completing five (05) years regular honorarium service;
- Whereas; as per legal opinion has been sought from the legal section which reveals as under "...presently there is no legal impediment in regularizing the services of respondent NO. 05 (Syed Akhtar Ali) as RReT provided he is satisfying other conditions required for such regularization under rules/norms..."
- Whereas this office has received Administrative approval vide letter dated:18.10.2019 with the direction to "...settle the issue of Mr.Syed Akhtar Ali ReT for regularization of his services as RRET if he has completed 05 years of services as ReT and is eligible for such regularization..."
- Whereas the case of Syed Akhtar Ali was put before the committee members constituted for scrutiny of the eligible un-regularized ReTs has also cleared the regularization of the ReT;
- 16- The Administrative Department has again recommended the case for regularization of the incumbent vide communication bearing NO: Edu/Legal/K/72/2019 dated: 27.5.2020;/
