Sanction is hereby accorded to the temporary appointment of **Ambreen Shah D/o Zahoor Ahmad Shah and Shugufta Arjmand** deceased Teacher, GHS Malabagh District Srinagar R/o **Shahi Mohalla Awanta Bhawan Tehsil Eidgah & District Srinagar** Qualification : 10+2 as **Lab. Bearer** (Class-IV), in the Pay Level-SL1 (14800-47100) against an available post in **Girls Higher Secondary School, Soura** District cadre Srinagar on compassionate grounds under SRO-43 of 1994.

The appointee shall report to the Chief Education Officer Srinagar within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates in original to be verified subsequently:-

1. *Academic Qualification Certificate.*
2. *Date of Birth Certificate.*
3. *Health Certificate from the concerned Chief Medical Officer of the District.*
4. *No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.*
5. *All other relevant documents as are required under SRO-43/1994.*

The appointment of the candidate shall further be subject to the following conditions:

- i. that she shall give an undertaking in the shape of an affidavit to the effect that "If, on verification, genuineness of the qualification certificates and other certificates/documents from the concerned issuing authority is found fake/forged, the appointment made shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her."
- ii. the salary of the appointee shall not be drawn and disbursed to her, unless a satisfactory report in respect of (i) above are received in her favour from the issuing authority.
- iii. the appointee shall be initially on probation for a period of two years.
- iv. the appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as per SRO-400 of 2009 dated 24-12-2009.
- v. if the appointee fails to join within a period of 21 days from the date of issuance of this order she shall cease her right of appointment which shall be deemed to have been cancelled ab-initio without any further notice.
