Whereas, Mr. Farooq Ahmad Teli S/O Ghulam Mohammad Telli R/O Chewa, Budgam meritorious candidate in the panel framed for engagement of one ReT (replacement case) for M/S Chewa in response to the notification No. DIPK 2823 dated 17.06.2009 was provisionally recommended for engagement as ReT for M/S Chewa; and

Whereas, during the process of selection, DSEK issued a communication vide No. DSEK/Plg/27/09/4019-30 dated 08.08.2009 that all the vacancies falling vacant in upgraded schools be filled up by engaging candidates with Math or Science background only; and

Whereas, the selection of Mr. Farooq Ahmad Teli S/O Ghulam Mohammad Teli R/O Chewa remained pending as the candidate in question was having Arts background and aggrieved due to delay in selection process, the ReT filed a suit under SWP No. 306/2010 before the Hon'ble High Court of J&K at Srinagar.

Whereas, a similar case under SWP No. 1945/09 titled Zahoor Ahmad Ganai vs. State and others was disposed off by the Hon'ble High Court of J&K at Srinagar alongwith all CMPs on 15/11/2010 with the direction to official respondents for issuing engagement order in favour of the petitioner in MS Bhatpara, in response to Advertisement notification dated 16.5.2009

Whereas, on challenging the above judgment of High Court dated 15.11.2010 by official respondent vide LPA No. 1113/2011 High Court upheld the earlier judgment dated 15.11.2010 and dismissed the appeal. Honoring the court direction dated 02.04.2013 Mr. Zahoor Ahmad Ganai, was engaged as ReT in GMS Batpora Narbal vide DSEK's approval No. DSEK/SSA/RT/Budgam/1039 dated 09.04.2013.

Whereas, Mr. Farooq Ahmad Teli, petitioner sought similar treatment as provided to Zahoor Ahmad, (SWP 1945/09) from DSEK on 25.04.2013 and DSEK vide No. DSEK/Legal/1675-Misc dated 25.04.2013 sought report from CEO Budgam and CEO Budgam, in a detailed report vide No. CEOB/Legal/B/338 dated 08.08.2013 sought instructions for the identical treatment to Farooq Ahmad Teli as was given to a similar case of another petitioner bearing SWP No. 1945/2009 titled Zahoor Ahmad Ganai as Farooq Ahmad Teli stands empanelled in the tentative selection list issued by CEO Budgam well before the amendment order dated 08.08.2009.

Whereas, in the meantime Hon'ble High Court vide IA No. 1624/2013 in SWP No. 306/2010 disposed off the said CMP on 04.06.2013 with the direction to the official respondents to accord consideration to the recommendations of CEO Budgam dated 08.05.2013 and take a final decision in accordance with rules pending of writ notwithstanding; and

Whereas, the CEO Budgam in compliance to above cited court direction dated 04.06.2013 and DSEK's communication No. DSEK/Legal/1675/Misc/6024 dated 19.11.2013 while providing identical treatment to the two cases SWP No 1945/2009 and SWP No. 306/2010 after giving due consideration to all facts of the case advised, this office vide order No. CEOB/Legal/B/1008-1010 dated: 28.11.2013 for issuing formal engagement order in favour of Farooq Ahmad Telli S/O Ghulam Mohammad Teli R/O Chewa as ReT at M/S Chewa subject the withdrawal of the petition 306/2010 un-conditionally from the Hon'ble High Court before joining the school, he has also to tender an affidavit signed by the 1st class judicial magistrate to the extent that he shall not claim for retrospective effect to his engagement as ReT in M/S Chewa.

Whereas, the case of the petitioner along with other similarly situated cases was taken up with the Administrative department for post facto approval to the engagement of the petitioner and the Administrative Department vide communication No. Edu-LGLOCoU/38/2021-04-SED(Cont.on P-2)

dated 03.11.2021- advised this directorate to decide the issue of petitioner and other similarly situated candidates at the directorate level itself.; and

Whereas, in compliance to Administrative Department's instructions, the case was placed before the designated committee in the meeting held and it has been advised that the similar nature cases be examined in light of the Administrative Department's instructions dated 03.11.2021 and during the course of examination it was observed that the candidate has been engaged as ReT by the Chief Education Officer, concerned in compliance to the Hon'ble Court directions wherein the Commissioner Secretary, School Education and Director, School Education, Kashmir also figure as Respondent No:1 & 2 and the order passed was to be complied by anyone of the official respondents, as such, the compliance of the order by concerned Chief Education Officer and tantamount to compliance by all the official respondents.

Now, therefore, the services of below mentioned ReT is hereby regularized in the pay scale of Rs. 5200-20200 with Grade Pay of Rs.2800/=(Pre-revised).



Whereas, the Zonal Education Officer, Narbal issued advertisement notification for filling up of three posts/vacancies that became available due to upgradation of Primary School Batpora in the year 2004-2005 on 01.12.2004 through print media; and

Whereas, eleven (11) candidates applied for the said posts and a panel of all the candidates who applied for the said post was prepared; and

Whereas, as per order of merit one among of the candidates namely Gh.Nabi Parray figuring at Serial NO:03 in the panel prepared by the ZEO concerned in consultation with Village Level Committee was engaged as ReT in the upgraded school vide order NO:ZEON/RT/SSA/56-57 dated:12.4.2005;and

Whereas, after some time one Gh.Ahmad Ganie figuring at Serial NO:06 in the panel came to know that one Gh.Nabi Parray has been engaged by producing fake date of birth certificate; and

Whereas, feeling aggrieved of such action Gh.Ahmad Ganai filed writ petition before the Hon'ble High court at Srinagar under SWP NO:169/13 titled Gh.Ahmad Ganie v/s state of Jammu and Kashmir and others; and

Whereas, the candidates figuring at S.NO:4 & 5 in the panel namely Zahoor Ahmad Zahoor and Bilal Ahmad Wani respectively were already appointed as government employees; and

Whereas, the petition under SWP NO:169/13 was disposed of by the Hon'ble High court on 10.10.2013 with the direction to respondents to consider the case of the petitioner for engagement as ReT teacher against the available vacancy created on account of resignation of private respondent NO:5 (Gh.Nabi parray);and

Whereas, after serving the said order to the concerned quarters the Chief Education Officer Budgam, vide communication NO:CEOB/legal/13/947-48 dated:23.10.2013 was advised to issue speaking orders/consideration in the light of court decision; and

Whereas, Zonal Education Officer, Narbal Budgam, issued speaking order in favour of Gh. Ahmad Ganie vide ZEO/N/13/1896 dated 23.10.2013 and found the claim of the petitioner is genuine- engaged Gh. Ahmad Ganie as ReT vide No. ZEO/N/13/1911-15 dated 30.10.2013.

Whereas, the case of the petitioner along with other similarly situated cases was taken up with the Administrative department for post facto approval to the engagement of the petitioner and the Administrative Department vide communication No. Edu-LGLOCoU/38/2021-04-SED dated: 03.11.2021 advised this directorate to decide the issue of petitioner and other similarly situated candidates at the directorate level itself.



Whereas, two posts of ReT teachers with mathematics and science background became available in the upgraded Primary School, Gund Mumdar, Beerwa Budgam, which were advertised by concerned ZEO in the year 2011 on revenue village basis and minimum prescribed qualification was 10+2 with mathematics and science background and two candidates namely Mr. Reyaz Ahmad Sheikh as well as Mr. Hilal Ahmad Bhat applied against the advertised posts; and

Whereas, Mr. Reyaz Ahmad Sheikh, was appointed as ReT against the science slot as he was possessing of 10+2 qualification; and

Whereas, the appointment of Mr. Reyaz Ahmad Sheikh was challenged by Mr. Hilal Ahmad Bhat in the Hon'ble High Court by a medium of SWP No. 281/2011 titled Hilal Ahmad Bhat V/s State and others- was dismissed by the Ld. Single Bench vide its judgment dated 06.11.2012 on the ground that respondent No.5 (Reyaz Ahmad) besides having eligibility of 10+2 was a science graduate, thus, possessed of superior merit than that of petitioner (Hilal Ahmad), who was only having qualification of 10+2;and

Whereas, the petitioner challenged judgment supra in an appeal bearing LPA No. 222/2012 titled Hilal Ahmad Bhat vs. State of J&K and others in the Hon'ble Division Bench of J&K High Court at Srinagar on the ground that appellant/ petitioner is possessing of superior merit at 10+2 level than that of the private respondent, who is Arts and not Science graduate and vacancy to be filled was subject specific, viz the candidate was required to have academic qualification in science subject, which respondent No. 5 was not possessing as he is Arts graduate; and

Whereas, that Hon'ble Court while allowing appeal has observed that the selection/ engagement is to be made on the basis of respective merit of competing candidates, so a higher qualification in a subject other than science and mathematics is to be excluded and the comparative merit of the competing candidates is to be determined on the basis of their qualifications in science and mathematics subject respectively. That while making above observation Hon'ble Court has put reliance upon G.O. NO. 1503-Edu of 2003 dated 01.10.2003;and.

Whereas, appellate court vide its order dated 04.02.2013 has set aside judgment dated 06.11.2012 passed in SWP No. 281/2011 and order of engagement / selection of respondent No.5 was quashed with a direction to official respondents of select and appoint the appellant/ petitioner as ReT in the upgraded Primary School, Gund Mumdar, Budgam ;and

Whereas, respondent No.5 has filed Review petition bearing No. 02/2013 against judgment supra, which was also dismissed by Hon'ble Court vide its order dated 04.12.2013;and

Whereas, that in compliance to judgment dated: 04.02.2013 passed by appellate Court, petitioner was engaged as ReT by Chief Education Officer concerned vide order No. CEOB/ Legal/169-73 dated 16.02.2013; and

Whereas, the case of the petitioner along with other similarly situated cases was taken up with the Administrative department for post facto approval to the engagement of the petitioner and the Administrative Department vide communication No: Edu-LGLOCoU/38/2021-04-SED dated: 03.11.2021 advised this directorate to decide the issue of petitioner and other similarly situated candidates at the directorate level itself; and

Whereas, in compliance to Administrative Department's instructions, the case was placed before the designated committee in the meeting held and it has been advised that the similar nature cases be examined in light of the Administrative Department's instructions dated 03.11.2021 and during the course of examination it was observed that the candidate

Whereas, applications were received by then Zonal Education Officer, Pulwama, for engagement of two ReTs at UPS Dalipora (B) Zone Pulwama from the eligible educated youths of concerned ward in the wake of upgradation of CS Dalipora (B) to the level of Upper Primary School, in pursuance to advertisement notice dated: 29.08.2004 issued by CEO Pulwama. The cut-off date for submission of applications before the office of ZEO concerned for the instant ReT slots was fixed as 25.09.2004;and

Whereas, a panel of 05 candidates was framed by ZEO Pulwama for instant engagement of two ReTs in UPS Dalipora (B) Zone Pulwama vide No. ZEO/Pul/05/1629 dated: 15.01.2005, since S.No.1 & 2 were notified by CEO concerned through print media on April 1st 2005 in local daily Kashmir Images and objections were invited against their proposed engagement. **S.No.1** of the panel viz Saba Nazir was engaged normally at relevant point of time and engagement of 2nd notified candidate figuring at S.No.2 of the panel viz Asima Jan was objected by Shakeela Akhter -S.No.3 of the panel to the effect that she has superior merit than the proposed notified candidates as her B.Ed Degree has not been considered for determination of inter-se merit of the candidates. The proposed engagement of Asma Jan was subsequently challenged before the Hon'ble High Court by Shakeela Akhter in SWP No. 291/05 titled Miss Shakeela Akhter vs. State and others. The objections were filed before the Hon'ble Court by the respondents, ZEO Pulwama, to the effect that the petitioner has not submitted the B.Ed certificate at the relevant point of time upto cut-off date which was fixed as 25.09.2004 for determination of merit/ eligibility of the candidates. The engagement against the 2nd. vacancy could not be finalized due to pendency of the above titled case before the Hon'ble High Court till S.No.2 of the panel Asma Jan was appointed as general line teacher through SSRB in the year 2013;and

Whereas, the petitioner Shakeela Akhter approached the Hon'ble Court with her plea that since S.No.2 of the panel Asima Jan has been appointed as General Line Teacher through SSRB and the petitioner figuring at S.No.3 now in place of Asima Jan who figure at S.No.2 has a right of consideration against 2nd vacancy even if her degree i.e. B.Ed is ignored. The Hon'ble Court disposed of the above titled writ petition vide order dated 04.02.2013, the operative portion whereof reads as under:-and

“...In view of the later development, petitioner figuring at S.No.3 now in place of Asima Jan who figure at S.No.2 has a right of consideration as against 2nd vacancy even if her degree i.e. B.Ed is ignored. The process of selection has not been finalized as yet, therefore, this petition is disposed of with petitioner's candidature for selection as against the vacancy No.2 in place of Mst.Asima Jan and thereafter finalize the process of selection in accordance with applicable rules and regulations within the period of six weeks from today.”

Whereas, the said court order was served to the respondent departments and after due consideration of the matter in light of court orders and directions of the Higher authorities, the candidate, Shakeela Akhter was engaged as ReT in UPS Dalipora Zone Pulwama vide CEO Pulwama order NO. CEO/Pul/Lit-14/666-70 dated 10.12.2014 and followed by ZEO Pulwama's order No. ZEO/Pul/Estt/15/80-85 dated: 20.06.2015; and

The regularization of ReT as RReT shall remain subject to the fulfillment of following conditions.

- ii. That the above named ReT has not remained on the rolls of any college/University during five years of honorarium service.
- iii. That the contribution in universal enrolment and retention of children has been maintained by the ReT;
- iv. That the CEO/DDO concerned are personally responsible to verify following original testimonials and ensure that the Rehbar-e-Taleem (ReT) fulfill all the conditions as laid down in Govt.order before giving effect to this order:
 - a) Academic qualification Certificate.
 - b) Age & health certificate.
 - c) Permanent Residence Certificate.
 - d) No loan certificate.
 - e) Character/Antecedents verification from IGP, CID.
 - f) ST certificate in case of ST candidates, if appointed under reserved category.
- vi) That ReT shall furnish an affidavit duly attested by Ist Class Judicial Magistrate to the effect:
 - a) in case adverse order/judgement from court he shall have no claim to the engagement /regularization;
 - b) He shall reimburse the amount whatsoever found due to him in case engagement of the candidate is quashed by the Hon'ble court;
 - c) If at any point of time adverse report with regard to qualification/ Character antecedents is received the applicant shall have no claim over engagement/regularization and the same shall stand cancelled in abinitio;
- viii) This order is issued without prejudice to any writ petition/suit, if pending in any Court of law which is not within the knowledge of this Directorate.
