Sub:- Select list of the candidates for the post of Teacher (Education Department) District Cadre Baramulla in pursuance to the advertised Notification No's 03 of 2012, 05 of 2013 and 06 of 2013 (Item No's 256, 447 & 401) respectively and operation of wait list thereof.

Whereas, the Administrative Department vide letter No. Edu-I/401/2014 dated 02.02.2015 forwarded the list of 800 candidates selected as Teachers for District Cadre Baramulla pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/2014/2955-61 dated 19.12.2014 and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;

Whereas, the Administrative Department in their earlier communication No. Edu-I/286/2012 dated: 05.09.2012 issued the guidelines to issue the provisional appointment orders in favour of the candidates for the post of teachers selected by the SSRB after taking the undertaking from the appointee with the following explicit conditions:-

The salary in favour of the selected candidates is only drawn:-

- After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;
- After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate;
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed)
- If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated against the candidates.
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the Judicial Magistrate.

Whereas vide this office Notification No. DSEK/Estt/III/B-Trs/05/2015/Sel-Bla/4567-68 dated 05.03.2015 followed by many such notifications published from time to time, these selectees were advised to submit their undertakings on the devised format and accordingly provisional appointment orders were issued in their favour;

Whereas, as many as Fifty (50) candidates under different categories/notifications either failed to deposit their undertakings or not joined in the concerned CEO's Office within the stipulated time period as intimated by Chief Education Officer Baramulla vide No. Estt/Tr/Bla/7738 dated 02.06.2015.

Whereas, vide this office notification No. Estt-III/B-Trs/05/2015/Baramulla/65228-32 dated 23.06.2015, these 50 candidates (who failed to join the department) were given final opportunity through Print Media to join the department within Seven days from the date of publication of the notification, failing which it shall be presumed that they are not interested to join the department and the resultant slots shall be filled from the wait list under respective items/categories.

Whereas, in response to the said notification dated 23.06.2015 (03/OM, 01/RBA & 01/ST=05) Five candidates showed their interest to join the department and submitted their undertakings on the devised format in the Directorate. Besides, two (02) candidates under SC Category (Item 401) have already been considered for provisional appointment, as such leaving Forty-three (43) candidates who failed to respond to the final opportunity;

Whereas, vide this office letter No. DSEK/III/05/2015/65558 dated 16.07.2015 the matter was taken up with the Administrative Department for conveying necessary instructions and in response the Administrative Department vide letter No. Edu-I/401/2014, dated 07.08.2015 has conveyed instructions for operating wait list against the slots which became available due to non-joining/non-depositing of undertakings of selectees;

Whereas, the SSB vide letter No. SSB/Sel/Secy/014/6975-81 dated 13/08/2014 issued instructions that in case the waiting list in respect of any candidate figuring in any item gets operated, the claim of such candidate for other places/item(s) in the wait list shall stand automatically forfeited.

Whereas, Chief Education Officer Baramulla vide letter No. 12431 dated 04.08.2015 and No. CEO/Bla/Estt/Tr/13017 dated 12.08.2015 has furnished undertakings of Seven (07) more candidates, in the shape of affidavits duly attested by 1<sup>st</sup> Class Judicial Magistrate to the effect that they are not interested to join the Department as Teacher and will not claim for their respective posts. As such the detailed vacancies which became available for operation of wait list are as under:-

Whereas, these (Thirty-four) 34 candidates who are in queue in the selection (wait list) of SSB District Cadre Baramulla against Notification No's 03 of 2012, 05 of 2013 and 06 of 2013 (Item No's 256, 447 & 401) and whose selection was not been kept withheld by the SSRB were advised to deposit their undertakings duly attested by the 1<sup>st</sup> Class Judicial Magistrate on the devised format in the Directorate of School Education Kashmir within Ten days from the date of publication of notification No. DSEK/Estt/III/B-Trs/66089-94 dated 09.09.2015;

Whereas in response to the said notification dated 16.04.2015, Twenty-nine (29 out of 34) candidates submitted their undertakings (leaving 05 candidates under SC Category, who failed to do so), duly attested by the 1<sup>st</sup> Class Judicial Magistrate on the devised format in the Directorate of School Education Kashmir for further appropriate action;

Now, therefore, sanction is hereby accorded to the provisional appointment of (15/OM, 05/RBA, 04/ST, 05/SC = 29) Twenty-nine candidates as Teachers in District Cadre Baramulla against the available slots in various categories/Items as per the Annexure. The candidates are required to report to the Chief Education Officer, Baramulla by or before 20th October, 2015 for further posting.

The Chief Education Officer Baramulla shall allow the candidates to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment orders of the above selectee shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court.
