The appointment of these candidates as "Urdu Teacher" is subject to the following conditions:-

- I. The appointees shall be on probation for a period of five years.

- IV. The appointees shall give an undertaking by way of affidavit duly attested by the 1st Class Judicial Magistrate to the effect that they will not apply for transfer in any case where he/she have been adjusted/posted.
- V. The appointees shall give an undertaking in shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled ab-initio and he/she shall have no claim of his/her appointment'
- VI. The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in any court of competent jurisdiction.

The appointees shall report to the Chief Education Officer Budgam within a period of 21 days from the date of issuance of this appointment order for seeking further posting orders on his own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities. In case of failure to join within stipulated time period, the appointment shall be deemed to have been cancelled ab-initio without any further notice.
