Whereas, the Administrative Department vide letter No. Edu-I/401/2014 dated 02.02.2015 forwarded the list of 800 candidates selected as Teachers for District Cadre Baramulla pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/2014/2955-61 dated 19.12.2014 and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;

Whereas vide this office Notification No. DSEK/Estt/III/B-Trs/05/2015/Sel-Bla/4567-68 dated 05.03.2015followed by many such notifications published from time to time, these selectees were advised to submit their undertakings on the devised format and accordingly-provisional appointment orders were issued in their favour;

Whereas, Chief Education Officer Baramulla vide communication No. CEO/Bla/14622 dated 28.08.2015 and No. CEO/Bla/16832 dated 10.09.2015 has intimated that Three more candidates have shown reluctance in joining the Department as Teacher and has forwarded undertakings of these (2+1) Threecandidates namely 1)Bashir Ahmad S/o Gh. Rasool Rather R/o Astan Mohalla Tarzoo Sopore under OM Category figuring at S.No. 1 to the Annexure of this office Order No. 2013-DSEK of 2015, Dated 03/07/2015 (SSB S.No. 24, Item 256 of Notification 03 of 2012), 2) Mohd. Ashraf Wani S/o Gh. Rasool Wani R/o Turka Batapora, Tangmarg, Baramulla and 3) Omar Parveiz S/o Ab. Aziz R/o Darhama Tangmarg, figuring at S.No. 2 and S.No.3 in item 256 of Notification 03 of 2012 under RBA Category respectively, duly attested by 1st Class Judicial Magistrate to the effect that they have no objection if the next in merit candidates are considered against their posts.

Whereas, the Administrative Department vide letter No. Edu-I/401/2014, dated 07.08.2015 has conveyed instructions for operating wait list against the slots which became available due to non-joining/non-depositing of undertakings of selectees:

Whereas due to non-joining of above named three candidates, three vacancies (01/OM and 02/RBA) became available against Notification No. 03 of 2012, dated 28.12.2012 (Item No. 256) for operation of wait list.

Whereas, the Administrative Department in their earlier communication. No. Edu-I/286/2012 dated: 05.09.2012 conveyed guidelines to issue the provisional appointment orders in favour of the selectees after obtaining the undertaking on the devised format with the following explicit conditions:-

## The salary in favour of the selected candidates is only drawn:-

- After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;
- After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed).
- If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated against the candidates.

Whereas, in light of above instructions of the Administrative Department all the **Three** (03)candidates furnished their undertakings on the devised format duly attested by the 1<sup>st</sup> Class Magistrate in response to this office notification No. Estt-III/B-Trs/66397-400 dated 03.10.2015;

Now, therefore, sanction is hereby accorded to the provisional appointment of following Three (03)candidates as Teachers District Cadre Baramullaagainst the available slots in various categories in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 for Graduates and above and Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidates are required to

report to the Chief Education Officer, Baramulla by or before 10thNovember, 2015 for further posting.

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- · Permanent resident certificates
- · Age and health certificates
- · Discharge certificate from the Institution attending/last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment orders of the candidates shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court.
