- 8. If on the verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled ab-initio.

In case the appointee fails to join and produce the certificates within 21 days from the date of issue of this order, the order will cease to operate without any notice to the appointee. The candidate be allowed to join provisionally in absence of verification of his character/antecedents report from the CID. In case of adverse report from the CID, the order should be deemed to have been cancelled ab-initio and he will have no claim for salary for the period he worked and an undertaking to this effect be also obtained from him for record and reference.
