Whereas, the Administrative Department vide communication Nos. Edu- 1/85/2019 dated 23.04.2019, No. Edu-1/87/2019 dated 26.04.2019 and No. Edu-I/86/2019 dated 09.05.2019 forwarded the lists of 1864 candidates who were recommended by the JKSSB for the posts of Urdu, Science-Math & General Teacher in District Cadre Anantnag, Baramulla, Bandipora, Budgam, Ganderbal, Kulgam, Kupwara, Pulwama, Shopian & Srinagar, to this office for issuance of formal appointment orders; and

Whereas, among others, the recommendations of 49 candidates having acquired degrees concurrently were kept withheld by the JKSSB; and

Whereas, Govt., vide Order No. 671-GAD of 2019 dated 13.06.2019, constituted a Committee for examining the issue of selectees having acquired degrees concurrently and the said committee recommended the deduction of 02 points in respect of such candidates having acquired degrees concurrently; and

Whereas, the JKSSB on the recommendations of the committee, released the recommendations in respect of **49 (1+48)** candidates vide Order No. 60-SSB of 2020 dated 05-02-2020 issued under endorsement No. SSB/Secy/Sel/2020/1273- 76 dated 05-02-2020 & Order No. 61-SSB of 2020 dated 05-02-2020 issued under endorsement No. SSB/Secy/Sel/2020/1277-81 dated 05-02-2020; and

Whereas, aggrieved with the JKSSB's Orders dated 05.02.2020, some candidates filed a Writ Petition before the Hon'ble High Court of Jammu & Kashmir at Srinagar through the medium of WP (C). No. 468/2020 CM No. 976/2020 Titled Manzoor Ahmad Dar & others Versus UT of J&K & others and the Hon'ble High Court in its Order dated: 24/02/2020 ordered as under:-

"Meanwhile, subject to objections and till next date before the Bench, operation of impugned order dated: 05th February 2020, shall not be given effect to. Alteration/modification on motion." ; and

Whereas, the Hon'ble Central Administrative Tribunal J&K Bench, Srinagar disposed-off the T.A. No. 4652/2020 titled Manzoor Ahmad Dar & others versus UT of J&K and others vide Order dated 03.08.2022 with the following observations:-

"... the official respondents were justified in nominating a committee to examine the issue of overlapping degrees with reference to the selection for the post of Teachers under reference. They were well within their rights to implement the recommendations of the said committee. We find no reason to question this action. We therefore find the present TA to be devoid of merit and the same is accordingly dismissed."; and

Whereas, in response to this office communication No.: DSEK/Estt/III/B-Trs/LIT/12/2020/5072 dated: 11/08/2022, the Administrative Department letter No.: Edu-NGK/436/2022-01 dated 21-12-2023 conveyed the approval of the Competent Authority for revalidation/operation of Select/Wait list of 49 candidates (38 candidates from Selection Zone and 11 from Wait Zone) for the post of Teacher General/Science-Math/Urdu for various Districts of Kashmir Division, beyond the date of its expiry viz; 04.02.2021 upto 31.05.2024 for appointment of these candidates in relaxation of Rule-14 of the J&K Civil Service (Decentralization and Recruitment) Rules,2010"; **and**

Whereas, vide this office Notification No. 01-DSEK of 2024, dated 01-01-2024, these 49 candidates were asked to submit all the testimonials/ certificates (in Original) and verification of Character and Antecedents Form prescribed by the Government in light of Order No. 28-JK (GAD) of 2021 dated 21-06-2021, within a period of 21 days from the date of issuance of Notification; **and**

Whereas, in response to the aforesaid Notification, 41 candidates submitted the requisite documents/certificates and Verification Roll in triplicate, to this Directorate within stipulated time frame of 21 days; **and**

Whereas, this Directorate has so far received satisfactory Character and Antecedents report from CID, J&K through designated portal in favour of 31 candidates (including 05 candidates appearing in more than 1 stream) with the following breakup:

Now, therefore, as recommended by the JKSSB vide No. Order No. 60-SSB of 2020 dated 05-02-2020 issued under endorsement No. SSB/Secy/Sel/2020/1273- 76 dated 05-02-2020 & Order No. 61-SSB of 2020 dated 05-02-2020 issued under endorsement No. SSB/Secy/Sel/2020/1277-81 dated 05-02-2020 and the approval conveyed by the Administrative Department vide letter No Edu-NGK/436/2022-01 dated: 21-12-2023, Sanction is hereby accorded to the Temporary Appointment in favour of **31 (Thirty One) candidates forming Annexure "A"** of this Order, for the post of **"General/Science-Math/ Urdu Teacher"** School Education Department, **District Cadre Anantnag, Baramulla, Bandipora, Ganderbal, Kulgam, Pulwama, Shopian, Srinagar** in pursuance to Advertisement Notification No. 06 of 2017 dated 28-12-2017 in the **Pay Level-05 (29200-92300)** as admissible in terms of S.O.425 of 2022 dated: 06-09-2022.

The appointee shall report to the Chief Education Officer, **Anantnag, Baramulla, Bandipora, Ganderbal, Kulgam, Pulwama, Shopian, Srinagar** within a period of 21 days from the date of issuance of this order for further posting and in case any of the

candidate(s) fail to join within stipulated time period, the Order issued in his/her favour shall be deemed to have been **cancelled ab-initio** without any further notice.

However, the Temporary Appointment of the candidate as Teacher (General/ Science-Math/Urdu) shall also be subject to the following terms and conditions:-

1. In case, at any stage, it emerges that the certificates/any relevant document furnished/produced by the appointee is/are fake/fictitious, the appointment order shall be cancelled ab-initio and criminal proceedings shall be initiated against the candidate.
2. The appointee at the time of joining shall produce following testimonials in Original to be verified subsequently by the concerned CEO/DDO from respective Issuing Authorities.
 - a. Domicile Certificate issued by the competent authority.
 - b. Matriculation/ Date of Birth Certificate.
 - c. Academic/ Qualification Certificate(s).
 - d. Health certificate from the concerned Chief Medical Officer of the District.
 - e. Certificates from the District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under any Self-Employment scheme has been availed by the appointee.
 - f. Valid relevant Category Certificate, if any applicable.
3. Each appointee shall furnish an Undertaking to the extent that the documents furnished by the candidate are genuine and shall be liable for termination of services/ criminal proceedings, in case any of the document(s) at any time is/are found fake/forged.
4. The Salary of the appointee(s) shall not be drawn and disbursed to them unless the genuineness of all documents (as indicated at 02 above) are received from the concerned Issuing Authorities.
5. The appointment of the candidates shall be governed under New Pension Scheme as per SRO-400 of 2009 dated: 24/12/2009.
6. The appointee shall be on probation for a period of 02 (two) years.
7. The appointment shall be subject to the final outcome of the cases/writ petition, if any, pending before any Hon'ble Court which may not be immediately within the knowledge of this Directorate.
