Sub:- Select list of the candidates for the post of **Teacher** (Education Department) **District Cadre Srinagar** advertised vide Notification No. 01 of 2012 dated 19.07.2012, Item No. 037 under Prime Minister's Special Package for Kashmiri Migrants and issuance of **Provisional appointment** thereof.

Whereas, the Administrative Department vide letter No. Edu-I/77/2017 dated: 17.04.2017 forwarded the selection list of 203 candidates selected as Teachers, under Prime Minister's Special Package for Kashmiri Migrants, for District Cadre Srinagar for issuance of appointment orders in their favour after fulfilling all formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar against Notification No. 01 of 2012 dated 19.07.2012 against item No. 037;

Whereas, among others, selection in respect of Neha Bhan & Sonaley Dhar was also kept withheld by the JKSSB which has now been released vide SSB's letter No. SSB/Secy/Sel/289/VIII/2017/250-52 dated 14.01.2020, No. SSB/Secy/Sel/289/ VIII/2017/283-85 dated 14.01.2020 read with No. SSB/Secy/Sel/2019/315 dated 14.01.2020 and conveyed by the Administrative Department vide communication No. Edu-I/908/2017-I dated 06.03.2020;

Now, therefore, sanction is hereby accorded to the provisional appointment of **Two** candidates (whose detailed particulars are reproduced below) as **Teacher** in **District Cadre Srinagar** against the additional posts created under Prime Minister's Special Package for Kashmiri Migrants in the minimum of Pay Level 5 (**Rs. 29,200-92,300/-**), as admissible under SRO-193 of 2018, dated 24.04.2018 and the **conditions of probation, pay and allowances and fixation of initial tenure of the appointees shall be governed by Jammu & Kashmir Probationer (Condition of Service, Pay & Allowances) and Fixation of Tenure Rules 2020** issued vide **S.O. 192 of 2020 dated 17.06.2020 read with Government Order No. 654-JK (GAD) of 2020 dated 19.06.2020.**

The provisional appointment shall be subject to the following conditions:-

- A) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled abinitio and he/she shall have no claim of his/her appointment;
- B) The appointee shall also furnish his agreement on the devised format duly attested by the 1st Class Magistrate in terms of SRO-412 of 2009 dated 31.12.2009;
- C) The verification of qualification certificates/reserved category certificate (wherever applicable) from the concerned issuing authority.

The Chief Education Officer, concerned shall allow the candidates to join on the post after verifying the following certificates (in original).

- *Character and antecedents certificates from Additional Director General of Police (CID)*

- *Qualification certificates viz Degree/Marks*
- *Permanent resident certificates*
- *Migration Certificate whereunder eligible for seeking employment under Prime Minister's Special Package for Kashmiri Migrants.*
- *Age and health certificates*
- *Discharge certificate from the Institution attending/ last attended*
- *Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.*
- *Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.*
- *Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.*

The DDO/CEO concerned shall draw and disburse the minimum salary of the appointee after obtaining formal appointment order from the appointing authority and the formal appointment order of the candidate shall be issued only after receiving verification reports viz. date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and **no salary till issuance of such orders shall be drawn.**

The provisional appointee shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the district under any circumstances. In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the action of his /her migration, in terms of the **agreement to be executed by each appointee under SRO-412 before the Chief Education Officer concerned.**

The appointees shall report to the Chief Education Officer Srinagar within a period of **21 days** from the date of issuance of this appointment order for seeking further posting orders till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities.

The candidate who fail to join within a period of 21 days from the date of issuance of the appointment order shall forego his/her right to appointment which shall be deemed to have been cancelled abinitio without any further notice" in light of the Circular instructions issued by the GAD vide No. 08-JK(GAD) of 2019 dated 04.12.2019.


The provisional appointment is subject to the final outcome of the cases, if any, pending before any Hon'ble Court, which are not immediately within the knowledge of this Directorate.
