Sanction is hereby accorded to the temporary appointment of **Ms. Ifrah Tariq** D/o **Tariq Hussain Peerzadah** deceased Principal BHSS Bandipora R/o **Nadihal** Tehsil & District **Bandipora** Qualification: 12th as **Lab. Bearer** (Multitasking Staff), in the Pay Level- SL1 (14800-47100) against an available post in **Higher Secondary school, Arin** District cadre **Bandipora** on compassionate grounds under SRO-43 of 1994.

The appointee shall report to the Chief Education Officer **Bandipora** within a period of **21 days** from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates in original to be verified subsequently:-

1. **Academic Qualification Certificate.**
2. **Date of Birth Certificate.**
3. **Health Certificate from the concerned Chief Medical Officer of the District.**
4. **No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.**
5. **All other relevant documents as are required under SRO-43/1994.**

The appointment of the candidate shall further be subject to the following conditions:

- i. that she shall give an undertaking in the shape of an affidavit to the effect that "If, on verification, genuineness of the qualification certificates and other certificates/documents from the concerned issuing authority is found fake/forged, the appointment made shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her."
- ii. the salary of the appointee shall not be drawn and disbursed to her, unless a satisfactory report in respect of (i) above are received in her favour from the issuing authority.
- iii. the appointee shall be initially on probation for a period of two years.
- iv. the appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as per SRO-400 of 2009 dated 24-12-2009.
- v. if the appointee fails to join within a period of 21 days from the date of issuance of this order she shall cease her right of appointment which shall be deemed to have been cancelled ab-initio without any further notice.
